The Board has now issued the enclosed Notice of Applications ("Notice") in the above matter.

You are directed:

- 1. to immediately serve a copy of the Notice in both the English and French versions, together with a copy of the Application, either personally, by courier, or by registered mail on the Clerks of all municipalities in which Union Gas supplies gas, and the English version only, together with a copy of the Application, on all Native Bands and Native Reservations to which Union Gas supplies gas, on all intervenors in EB-2005-0520, on Enbridge Gas Distribution Inc., on Natural Resource Gas Limited and on the Norfolk Federation of Agriculture;
- to immediately arrange for the English version of the Notice, headed with the Ontario Government logo and the words "Ontario Energy Board", to be published in one issue of English-language daily newspapers and one issue of English language weekly newspapers having the highest circulation, according to the best information available, throughout Union Gas' service areas;
- 3. to immediately arrange for the French version of the Notice, headed with the Ontario Government logo and the words "Commission de l'énergie de
