Re: Status Report on Load Transfer Elimination Applications

Board File No.: EB-2015-0006

On December 21, 2015, the Ontario Energy Board (OEB) issued a Notice of Amendments to the Distribution System Code (EB-2015-0006), related to the Elimination of Load Transfer Arrangements between electricity distributors (LDCs) and amended the Distribution System Code (DSC) accordingly. As per section 6.5.3 of the DSC, all LDCs are required to eliminate all load transfer arrangements by June 21, 2017. As well, section 6.5.6 prohibits LDCs from entering into any new load transfer arrangements.

On March 30, 2016, the OEB issued a <u>Letter</u> setting out the implementation process, developed in conjunction with an operationally focused distributor working group for Elimination of Load Transfer Arrangements and introduced an expedited service area amendment (SAA) and asset transfer approach.

With the June 21, 2017 deadline fast approaching, the OEB is seeking a status report from all LDCs regarding progress towards achieving the load transfer elimination requirement. Each LDC is required to complete Load Transfer Elimination Status Form (available in Appendix A) for any of the remaining load transfer arrangements. All completed forms should be sent to the Board Secretary via e-mail at BoardSec@oeb.ca no later than Friday, May 19, 2017. Please include [LDC name] - LTLT Status Report in the subject line of your submission e-mail.
