## Hydro One Sault Ste. Marie LLP

### Application for electricity transmission revenue requirement effective January 1, 2017

#### PROCEDURAL ORDER NO. 2

May 26, 2017

Hydro One Sault Ste. Marie LLP (Hydro One SSM) filed an application with the Ontario Energy Board (OEB) on December 28, 2016 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) and under the OEB's Filing Requirements for Electricity Transmission Applications, seeking approval for changes to its electricity transmission revenue requirement to be effective January 1, 2017.

The OEB issued Procedural Order No. 1 on March 29, 2017, which provided for the filing of interrogatories and responses. Hydro One Sault Ste. Marie filed its responses to interrogatories on May 4, 2017.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

#### IT IS THEREFORE ORDERED THAT:

1. Hydro One SSM shall file its Argument-in Chief with the OEB and forward it to all parties on or before **June 8, 2017**.
2. OEB staff shall file its submission with the OEB and forward it to all parties on or before **June 22, 2017**.
3. Intervenors shall file any submissions with the OEB and forward them to all parties on or before **June 30, 2017**.

4. Hydro One SSM shall file its reply submission with the OEB and forward it to all parties on or before **July 14, 2017**.

All filings to the OEB must quote the file number, **EB-2016-0356** and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.oeb.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <http://www.oeb.ca/OEB/Industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
