APPLICATION AMENDMENT

1. Enbridge Gas Distribution Inc. ("Company") filed an Application with Board on May 16, 2017, pursuant to the provisions of the *Municipal Franchises Act*, R.S.O. 1990, C. M. 55, as amended ("Act") for an Interim Order granting the extension of the term of the right to construct or operate works for the distribution of gas in the Town of Hawkesbury ("Municipality") and of the right to extend or add to such works.
2. As noted in the Application, the Company's Franchise Agreement with the Municipality ("Agreement") will expire on July 2, 2017. It is possible that the Agreement will expire before the Board has disposed of the Application.
3. In addition to the relief requested in the Application, the Company hereby applies to the Board for an Interim Order, pursuant to subsection 10(4) of the Act, for an extension of its rights under the Agreement.
