# Union Gas Limited Application for a licence to drill one injection/withdrawal well and for approval to construct natural gas pipeline in the Terminus designated storage area in the Township of St. Clair in Lambton County

#### PROCEDURAL ORDER NO. 1 June 8, 2017

Union Gas Limited (Union Gas) filed an application dated March 29, 2017 with the Ministry of Natural Resources and Forestry (MNRF) for one well drilling licence in the Terminus designated storage area (Terminus Pool). The application was referred to the Ontario Energy Board (OEB) by the MNRF on April 12, 2017, pursuant to section 40 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15 (schedule B) (OEB Act).

Union Gas has also applied under section 90 of the OEB Act for leave to construct approximately 330 metres of 12 inch diameter pipeline in the Terminus Pool.

The OEB issued a Notice of Hearing on May 9, 2017. Enbridge Gas Distribution Inc. (Enbridge Gas) and the MNRF applied for intervenor status. Union Gas did not file any objection.

Enbridge Gas and MNRF are granted intervenor status. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

#### IT IS THEREFORE ORDERED THAT:

- 1. OEB staff and intervenors shall request any information and material from Union Gas that is in addition to Union Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Union Gas by **June 23, 2017**.
- 2. Union Gas shall file with the OEB complete written responses to the interrogatories and deliver them to intervenors by **July 7, 2017**.
- Unless the OEB orders otherwise, any written submission by OEB staff and intervenors shall be filed with the OEB and delivered to all parties by July 21, 2017.
- 4. Unless the OEB orders otherwise, Union Gas may file a written reply submission with the OEB, and deliver it to intervenors by **August 4, 2017**.

All filings to the OEB must quote the file number, EB-2017-0162 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <a href="https://www.pes.ontarioenergyboard.ca/eservice/">https://www.pes.ontarioenergyboard.ca/eservice/</a>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <a href="https://www.oeb.ca/industry">https://www.oeb.ca/industry</a>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
