I am writing on behalf of the Rice Lake Tourist Association (RLTA), who represents more than 30 resort and non-resort members in the Rice Lake/Northumberland area. In the case of EB-2017-0049, I request that the RLTA be named an intervenor in Hydro One Networks Inc. application to raise electricity and distribution rates and other charges.

Increases to our electricity and distributions rates will have negative impacts to our businesses, which rely heavily on seasonal visitors mainly in the spring and summer. We have already seen cancellations and suffered property damage due to the adverse effects of climate change, including flooding and cooler temperatures. During the winter months, when many of us are not drawing income from the businesses, we still pay high delivery charges. Increases to rates during this time are difficult to digest, especially if we get a particularly bad spring/summer season, which is what 2017 is anticipated to be.

The RLTA is participating as an intervenor to ensure that any price increases are explained and justified and that our interests are fully represented.

Our organization operates on a shoestring budget to promote cottage accommodations and outdoor experiences at an affordable price to families and we rely on partner organizations to help with any shortfalls in funding. We do not have other funding sources to ensure experienced representation to participate in and assist the board in these proceedings. Therefore, RLTA would respectfully request a determination of eligibility for cost award in this proceeding.
