I am writing on behalf of the Sunset Bay Road Cottagers, who represent more than 40 year-round and seasonal homes on Rice Lake in the Northumberland area. In the case of EB-2017-0049, it is being requested that Eva Haralabidis be named as intervenor in Hydro One Networks Inc. application to raise electricity and distribution rates and other charges.

In general, members of our community are opposed to increases to our electricity and distribution rates at a time when the provincial government recognizes that electricity costs need to be lowered and have committed to lowering them. Higher fees with Hydro One will close the gap on property owner's opportunity for hydro cost savings and directs a portion of those savings to Hydro One.

The property owners listed below request that Eva Haralabidis participate as an intervenor on behalf of Sunset Bay Road Cottagers to ensure that any price increases are explained and justified and that our interests are fully represented.

As a non-profit community group, The Sunset Bay Road Cottagers do not have funding sources to ensure experienced representation to participate in and assist the board in these proceedings. Therefore, it is respectfully being requested that a determination of eligibility for cost award in this proceeding be considered.
