RE: Electricity Generation Licence EG-2016-0290 – Transfer request

Dear Sir or Madam,

Please find this letter on behalf of SLS Wind Development II LP and SLS ZEP Wind Corp. as application to the Ontario Energy Board (the "OEB") for leave to transfer generation licence EG-2016-0290 pursuant to section 18(2) of the Ontario Energy Board Act, 1998, as more particularly described herein.

By way of background, **SLS ZEP Wind Corp.** is the holder of electricity generation licence EG-2016-0290 issued by the OEB on November 24, 2016 (the "Licence"), in respect of a generation facility that reached commercial operation in April 2017, the Settlers Landing Wind Park (8.0 MW, FIT Reference # FIT-F856F47, the "Facility"), as tabulated below. The Facility is jointly-owned pursuant to a joint venture arrangement entered into by **SLS ZEP Wind Corp.** and **SLS Wind Development LP**; the latter is a wholly-owned subsidiary of Capstone Power Corp. (Capstone). As noted, Capstone, through its subsidiary, SLS Wind Development LP, is the sole licenced operator of the Facility. As a parent

company, Capstone currently owns and operates ten wind facilities in Ontario.

Now that the Facility has reached commercial operation, we are undergoing a restructuring whereby the ownership interests of SLS ZEP Wind Corp. (a non-Capstone subsidiary) will be transferred to a new Capstone subsidiary, SLS Wind Development II LP (the "Licence Transferee" or "Purchaser"). The Licence Transferee will hold an ownership interest in the Facility, but will not be a licenced operator or engaged in operations. Accordingly, we confirm that the change in ownership and corresponding licence transfer will not result in any impact to the normal course of operation of the Facility.

## Third Party Consent Required

As a condition precedent to close of the transaction, we require consent from the FIT contract counterparty (the IESO). IESO is currently engaged in this request, and we anticipate executing a

Consent, Assumption and Acknowledgement Agreement (or similar form of agreement) by the end of the month.
