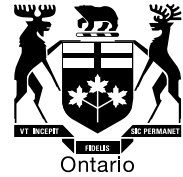

**LETTER OF DIRECTION**

Dear Mr. Lippold:

**Re: Natural Resource Gas Limited  
Application to correct reference prices in the Purchased Gas  
Transportation Variance Account for the years 2011-2015  
Board File Number: EB-2017-0215**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Natural Resource Gas Limited's application for approval to correct the reference prices used in the Purchased Gas Transportation Variance Account (Notice). Please note that you must serve the Notice to the parties identified below **within fourteen days** of the date of this letter. If service is not possible within fourteen days, you must inform the Registrar immediately at [Registrar@ontarioenergyboard.ca](mailto:Registrar@ontarioenergyboard.ca).

You are directed:

1. To arrange immediately for the service of the Notice, in the exact form accompanying this letter, except:
  - a. For the Notice, under the sections entitled "**BE INFORMED AND HAVE YOUR SAY**" and "**ORAL VS. WRITTEN HEARINGS**" remove the bold and bracketed words "[applicant will insert actual date 10 calendar days from the date the notice is posted on the applicant's website]"; and
  - b. Insert the same date which shall be determined by adding 10 calendar days to the date that the Notice will be posted on Natural Resource Gas Limited's website in accordance with the requirements of paragraph 4 below. If that date falls on a "holiday" as defined in Rule 6.02 of the OEB's

*Rules of Practice and Procedure*, insert the next date that is not a holiday. Use the following date format “**January 1, 2016**” for the Notice.

2. Once the requirements of paragraph 1 are completed, to immediately and prior to completing any other steps required in this letter of direction, file with the OEB a pdf version of the complete Notice (Dated Notice).
3. No later than the date the Notice is posted on Natural Resource Gas Limited’s website in accordance with paragraph 4, to serve a copy of the Dated Notice, the application and the evidence, directly on:
  - a. the clerks of the affected municipalities
  - b. all First Nations Bands and First Nation Reserves to which Natural Resource Gas Limited supplies gas
  - c. all intervenors in EB-2016-0236 and EB-2016-0351
  - d. Union Gas Limited and Enbridge Gas Distribution Inc.
4. To make a copy of the Dated Notice, the application and the evidence, and any amendments thereto, available for public review at Natural Resource Gas Limited’s office and in a prominent place on Natural Resource Gas Limited’s website.
5. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 4 above immediately thereafter.
6. To provide a copy of the Dated Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Dated Notice other than documents or materials expressly required by this letter of direction to be served.
