EB-2017-0234 – Recalculating the Rural or Remote Electricity Rate Protection (RRRP) Charge – Hydro One Networks' Inc. Response

As requested in the Ontario Energy Board's letter of June 19, 2017 related to proceeding EB-2017-0234, this response confirms Hydro One Networks Inc.'s (Hydro One's) estimate of the amounts referred to in subsections 5(14) to (16) of the recently amended Ontario Regulation 442/01 (Rural or Remote Electricity Rate Protection), which takes effect July 1, 2017.

In accordance with subsection 5 (14) of the amended regulation, provided below is an estimate of the RRRP rate protection amounts paid by Hydro One for electricity consumed over the period from January 1 to June 30, 2017 as well as the RRRP amounts paid in 2017 for energy consumed in December 2016. Also provided below are the amounts received from the Independent Electricity System Operator (IESO) in 2017 to cover the rate protection amounts paid by Hydro One in accordance with Ontario Regulation 442/01.



As indicated below, Hydro One estimates that it will receive from the IESO \$1,780,974 in excess of the rate protection amounts paid to eligible customers, and in accordance with subsection 5 (16) of the amended regulation Hydro One shall transfer this amount to the IESO, subject to any adjustments to reflect the actual rate protection amounts paid for consumption to June 30, 2017.
