This letter is to confirm Hydro One Networks Inc.'s ("Hydro One") agreement to sell a pole currently owned by Hydro One to Bell Canada, conditional to the Ontario Energy Board's ("OEB") approval. This also confirms that Bell Canada supports Hydro One to proceed with the Section 86(1)(b) application without a hearing.

The sale will be conditional on the following reassurance being given to Hydro One:

**1.0** Acceptance of the existing joint use tenants, where applicable, whose tenancy with Hydro One will be subsequently terminated upon the sales transaction.

The one pole will be transferred, following the OEB's approval, on an "as is, where is" basis, pursuant to Hydro One's Joint Use agreement. The asset being sold in this transaction is described as follows and supported by the attached map.
