Joint Application for Elimination of Load Transfer Arrangements

INTRODUCTION AND SUMMARY

COLLUS PowerStream Corp. (COLLUS PowerStream) and Wasaga Distribution Inc. (Wasaga) have jointly applied to the Ontario Energy Board (OEB) for approval to amend the service areas of both distributors such that load transfer arrangements between the two distributors are eliminated. A load transfer arrangement is a situation in which a customer located in the licensed service area of one distributor (the geographic distributor) is physically served by another distributor (the physical distributor).

The application is granted, as set out in this Decision and Order.

THE PROCESS

This Decision and Order is being issued without a hearing by Delegated Authority, pursuant to Section 6(4) of the *Ontario Energy Board Act, 1998* (the Act).

THE APPLICATION

COLLUS PowerStream and Wasaga (collectively, the Applicants) filed a joint application on May 18, 2017 under sections 74 and 86(1)(b) of the Act.

The application was filed pursuant to the Distribution System Code (DSC) amendments made by the OEB in EB-2015-0006 and in accordance with the OEB's filing guidelines for combined service area amendments and sale of assets. In EB-2015-0006, the OEB set out its policy on the elimination of load transfer arrangements between electricity distributors in Ontario. On December 21, 2015, section 6.5.3 of the DSC was amended to require distributors to eliminate all load transfer arrangements by June 21, 2017, and section 6.5.6 was amended to prohibit distributors from entering into any new load transfer arrangements.

Through the application, COLLUS PowerStream seeks to transfer four "Residential", four "General Service" and one "MicroFIT" customers to Wasaga. There are no customers being transferred from Wasaga to COLLUS PowerStream, as part of this application.

COLLUS PowerStream also requests the OEB's approval to sell the distribution assets servicing the affected customers to Wasaga. Since the distribution assets servicing these customers have fully depreciated, COLLUS PowerStream has proposed to sell

them to Wasaga for \$0. The Applicants submit that there are no third parties impacted by this transfer and no assets will be stranded, if the application is approved.

FINDINGS

The OEB finds it to be in the public interest to approve the service area amendments and transfer of assets as proposed by the Applicants in order to eliminate the load transfer arrangements between COLLUS PowerStream and Wasaga. COLLUS PowerStream and Wasaga's licences will be amended to reflect the proposed transfer of the affected customers.

The Residential and General Service customers being transferred from COLLUS PowerStream to Wasaga will see a reduction in their monthly delivery charges and, therefore, no credits are required for these customers.

COLLUS PowerStream and Wasaga are reminded that both geographic and physical distributors shall ensure that all relevant customer information including, but not limited to, information regarding security deposits and consumption is properly transferred to the physical distributor to allow for the continuous billing of customers and the continuous application of Ontario Electricity Support Program (OESP) rate assistance to the bills of eligible customers.

IT IS ORDERED THAT:

1. Schedule 1 of COLLUS PowerStream Corp.'s Electricity Distribution Licence (ED-2002-0518) is amended. The amended licence is attached to this Decision and Order.
2. Schedule 1 of Wasaga Distribution Inc.'s Electricity Distribution Licence (ED-2002-0544) is amended. The amended licence is attached to this Decision and Order.
3. COLLUS PowerStream Corp. is granted leave to sell assets listed in Schedule A (Table 1) to Wasaga Distribution Inc.
