

Five Nations Energy Inc.

**Application for changes to its electricity transmission
revenue requirement effective January 1, 2016**

**PROCEDURAL ORDER NO. 4
July 11, 2017**

Five Nations Energy Inc. (Five Nations Energy) filed a cost of service application with the Ontario Energy Board (OEB) on July 27, 2016 (completed November 25, 2016) under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to its transmission revenue requirement effective January 1, 2016. Five Nations Energy recovers its approved revenue requirement through Ontario's Uniform Transmission Rates.

In Procedural Order No. 3, issued June 5, 2017, the OEB set July 6 and 7, 2017 as the dates for the oral hearing. The oral hearing was held on the scheduled dates.

At the conclusion of the oral hearing, the OEB discussed potential deadlines for the filing of undertaking responses and argument.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD THEREFORE ORDERS THAT:

1. Five Nations Energy shall file with the OEB complete responses to the undertakings given at the oral hearing and deliver them to Energy Probe by **July 28, 2017**.
2. Five Nations Energy shall file its argument-in-chief, if any, with the OEB and serve it on Energy Probe by **August 4, 2017**.

3. OEB staff and Energy Probe shall file written submissions, if any, with the OEB and serve all parties by **August 23, 2017**.
4. Five Nations Energy shall file its reply argument, if any, with the OEB and serve it on Energy Probe by **September 8, 2017**.

All filings to the OEB must quote the file number, **EB-2016-0231** and be made electronically in searchable/unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available, parties may email their documents to the address below.
