# Application for payment amounts for the period from January 1, 2017 to December 31, 2021

## PROCEDURAL ORDER NO. 9 July 11, 2017

Ontario Power Generation Inc. (OPG) filed an application with the Ontario Energy Board (OEB) on May 27, 2016 under section 78.1 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes in payment amounts for the output of its nuclear generating facilities and most of its hydroelectric generating facilities. The request seeks approval for nuclear payment amounts to be effective January 1, 2017 and for each following year through to December 31, 2021. The request seeks approval for hydroelectric payment amounts to be effective January 1, 2017 to December 31, 2017 and approval of the hydroelectric payment amount setting formula for the period January 1, 2017 to December 31, 2021.

In Procedural Order No. 1 issued on August 12, 2016, the OEB determined that the following intervenors are eligible to apply for an award of costs in this proceeding under the OEB's <u>*Practice Direction on Cost Awards*</u>:

The OEB considers it necessary to make provision for the following matters related to this proceeding.

## THE ONTARIO ENERGY BOARD THEREFORE ORDERS THAT:

- 1. Intervenors eligible for cost awards shall file with the OEB and forward to OPG their respective cost claims for the period up to and including May 29, 2017 by **August 14, 2017**.
- 2. OPG shall file with the OEB and forward to intervenors any objections to the claimed costs by **September 5, 2017**.
- 3. Intervenors shall file with the OEB and forward to OPG any responses to any objections for costs claimed by **September 18, 2017**.
- 4. OPG shall pay the OEB's costs incidental to this proceeding upon receipt of the OEB's invoice.

All filings to the OEB must quote the file number, **EB-2016-0152**, be made in searchable / unrestricted PDF format electronically through the OEB's web portal at <a href="https://www.pes.ontarioenergyboard.ca/eservice/">https://www.pes.ontarioenergyboard.ca/eservice/</a>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address.
