Application for approval to correct reference prices used in the Purchased Gas Transportation Variance Account for fiscal years 2011 to 2015

PROCEDURAL ORDER NO. 1 July 13, 2017

Natural Resource Gas Limited (Natural Resource Gas) filed an application with the Ontario Energy Board (OEB) on June 2, 2017, seeking approval to correct the reference prices used in Natural Resource Gas' Purchased Gas Transportation Variance Account (PGTVA) as approved by the OEB in EB-2010-0018¹. Natural Resource Gas has noted that it has not requested disposition of the PGTVA balances for fiscal years 2011 to 2015 in this application and therefore there is no rate impact on NRG's ratepayers as a result of the requested correction.

A Notice of Hearing was issued on June 20, 2017 and was served and posted as per the direction of the OEB. The last date for intervention was July 4, 2017.

Union Gas Limited (Union Gas) requested intervenor status. Union Gas did not request cost awards. No objections were received regarding the request for intervenor status. Intervenor status is granted to Union Gas.

The application will proceed by way of a written hearing. It is necessary to make provision for the following matters related to this proceeding.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and Union Gas shall request any information and material that they require from Natural Resource Gas that is in addition to Natural Resource

Gas' evidence and that is relevant to the hearing, by written interrogatories filed with the OEB and delivered to Natural Resource Gas by **July 21, 2017**.

- 2. Natural Resource Gas shall file with the OEB complete responses to the interrogatories and deliver them to Union Gas by **July 28, 2017**.
- 3. Unless the OEB orders otherwise, any written submission by OEB staff and Union Gas shall be filed with the OEB and delivered to all other parties by **August 8, 2017**.
- Unless the OEB orders otherwise, Natural Resource Gas may file a written reply submission with the OEB, and deliver it to Union Gas by August 15, 2017.

All filings to the OEB must quote the file number, EB-2017-0215 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <u>https://www.pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>https://www.oeb.ca/industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies.
