CV – Ron Tolmie

Physics graduate: Dalhousie University (1953). Worked for the Nova Scotia Research Foundation on geophysical surveys throughout Nova Scotia (gravimeter, magnetic, resistance) including the first seismic study of a salt dome near Sable Island that has since become a major gas/oil resource. Joined Atomic Energy of Canada Ltd. in 1955, remaining there for 15 years. Developed a wide range of nuclear instruments for radiation monitoring and for geophysical and industrial applications of nuclear technology. One was a very high speed Ge gamma ray spectrometer for monitoring fission products in Candu power reactors. Head of the Measurement and Instrumentation Section and then Manager of the Industrial Metrology Program. Designed the large aerial gamma ray spectrometer that was used by the Geological Survey of Canada to map the Canadian shield, an Sb:Be neutron source for neutron activation analysis, and developed the basic technology of Si:Li X-Ray Fluorescence analysers. The latter was licensed by AECL to IRAD instruments Ltd to commercialize the XRF technology (became President of IRAD). IRAD developed a range of XRF analyzers, ranging from a small portable unit to laboratory analysers to very large multi-stream systems that were used to control the operations of many of Canada's mine mills, primarily for Cu, Zn and Pb.

I semi retired in 1998 to pursue technologies that could lead to sustainable energy systems. Initially these systems used thermal storage (85% of the energy used by our homes in Canada is needed for thermal applications). I realized that thermal storage systems can concurrently store electricity, returning the electricity to the grid via several indirect mechanisms, and that electricity storage makes it possible to greatly increase the generation of hydro and wind energy and to eliminate the need for using fossil fuels for both heating and power generation. Such systems draw most of their energy from the summer air which is a virtually unlimited (and very inexpensive) energy source that could also replace the power that is presently supplied by Ontario's nuclear power stations. Present activities center on explaining how such systems work and how they could be applied in Canada, the US and Europe. They can be applied over a wide size range, ranging from making individual homes nearly self-sufficient for energy to large district heating/cooling/power systems.
