Pursuant to the Board's Procedural Order dated July 11, 2017, we enclose a Cost Claim on behalf of our client, Canadian Manufacturers & Exporters ("CME"), for services rendered up to and including May 29, 2017.

A copy of this Cost Claim has been forwarded to OPG as instructed in the Procedural Order.

Please note that the time claimed on behalf of Vincent J. DeRose includes the time recorded while he was a partner at this firm, as well as time recorded as co-counsel to CME as a member of the firm of Tereposky & DeRose LLP. Mr. DeRose's hourly rate of \$290.00 applies to all hours recorded in this Cost Claim.

Based upon the hours spent by all counsel, CME's total fees in this claim would be \$184,424.00. We have voluntarily reduced Scott Pollock's fees by \$15,130.00, which reduces the total fees to \$169,294.00.

At the time of the Pre-hearing Conference and the Technical Conference, CME confirmed that they would not be billing Scott Pollock's time for these activities, which represent 23.6 hours and \$4,000.00. The reduction of \$15,130.00 includes removal of all of his time dealing with the


Pre-Hearing Conference and Technical Conference, and also includes a substantial reduction for the time attributable to the Oral Hearing and Argument Preparation.

The overall reduction is intended to address overlap between Mr. Pollock and Ms. Blanchard and Mr. DeRose, which overlap was necessary in order to bring Mr. Pollock up to speed on the complex issues involved in this case.

We hope the Board will appreciate our proactive review of the reasonableness of this Cost Claim.
