**Re: CPA Cost Claim
 EB-2015-0179**

We are counsel to the Canadian Propane Association (the “CPA”), an intervenor in proceeding. The CPA participated in both phases of this proceeding, which for clarity are referenced as follows:

Phase I	July 23, 2015 to January 20, 2016	Period from the date of Union’s original application submission to the date that the OEB put the application “on hold” in order to hold a generic hearing.
Phase II	November 17, 2016 to August 10, 2017	Period from the date that the OEB resumed the Union application to the date the OEB issued its Decision.

The Board ordered in Procedural Order No. 1 that CPA be granted intervenor status in this proceeding and determined that CPA is eligible for an award of costs under the OEB’s *Practice Direction on Cost Awards*.

Accordingly, enclosed are two copies of CPA’s costs submissions, in accordance with the Decision and Order, issued by the Board on August 10, 2017. For ease of reference, we have completed separate submissions for each of Phase I (\$25,315.38) and Phase II (\$19,800.82).

We note that the CPA was a full participant in Phase I of the proceeding, such participation having included:

1. a review of the Application;
2. active participation in the initial Interrogatories stage;
3. preparation for a Technical Conference ordered pursuant to Procedural Order #1;
4. preparation for a Pre-Hearing Conference ordered pursuant to Procedural Order #2;
5. preparation for an Oral Hearing ordered pursuant to Procedural Order #2;
6. submission of notice of intent to file evidence and a description of that evidence, as requested by the Board pursuant to Procedural Order #2;
7. submission of a detailed description of evidence to be filed, as requested by the Board pursuant to Procedural Order #3;
8. preparation of CPA's evidence (including expert witness reports) in order to be able to submit the detailed descriptions of evidence referenced in 6 and 7 above; and
9. attendance at the pre-hearing conference.

CPA also participated in Phase II of the proceeding, such participation having included:

10. a review of the amended Application;
11. active participation in the second Interrogatories stage;
12. preparation for and participation in a Settlement Conference and the settlement proposal discussions that followed; and
13. submission of written arguments.

In accepting CPA's participation in Phase II, the Board directed in a letter dated May 2, 2017 that CPA's submissions from that point forward be limited to the issue of a rate stability period.

We anticipate, based on Union's prior submissions, that Union might object to the within cost submissions by asserting that the CPA exceeded the scope permitted by the Board in its May 2, 2017 letter. In an effort to proactively address such an objection and offer a reasonable compromise, we submit the following:

- A. There were no limitations on the scope of the CPA's participation in Phase I or at any time prior to May 2, 2017, and there has been no suggestion that the CPA exceeded the

scope of the issues at any point in Phase I, or at any point prior to May 2, 2017. Accordingly, the CPA submits that the costs claimed within for the period from July 23, 2016 to May 2, 2017 should not be open to any such objection.

B. Following May 2, 2017, the CPA's costs in Phase II relate primarily to (i) the preparation of Phase II Interrogatories, (ii) participation in the Phase II Settlement Conference process, and (iii) preparation of written argument for Phase II.


- (i) Phase II Interrogatories: The CPA submitted five questions to Union in the Phase II Interrogatories process. All five questions were geared toward understanding Union's interpretation of, proposal for the imposition of, and determination of rates during, a "rate stability period" (noting that until an explanation was provided by Union in response to those interrogatories and at the Settlement Conference, it was unclear what Union meant by its rate stability period and how, if at all, this differed from the SES Term).
- (ii) Phase II Settlement Conference: CPA attended the Settlement Conference and various discussions and correspondence regarding settlement proposals. As there was no Settlement Conference held solely to deal with rate stability, and no Settlement Proposal put forward solely on the subject of rate stability, CPA's participation could not be segregated on an issue by issue basis (i.e. it was not feasible for CPA's counsel to leave the room to work on other client matters each time a party raised another issue). CPA had no choice but to attend the full Settlement Conference and the conference calls which followed.
- (iii) Phase II Written Argument: CPA is of the opinion that its Argument submissions are in scope, and Union itself recognized in its Reply that "CPA made various submissions regarding the rate stability period".¹ However, we recognize as well that Union takes the position some of CPA's Argument is beyond the permitted scope, and that the Board in its Decision and Order echoed this position.

Accordingly, CPA proposes that while its costs incurred in connection with Phase I (prior to May 2, 2017) and with Phase II Interrogatories and Phase II Settlement Conference be recognized in full, its costs incurred in connection with Phase II Written Argument should be reduced by 50%, in recognition that some of the time spent preparing written argument was within scope while some may have been out of scope. As 24.7 hours were spent by counsel on Phase II Written Argument, we propose a reduction of 12.35 hours from the attached cost claim, or **a \$3,904.70 reduction** ([1.05 hrs x \$170] + [11.3 hrs x \$290] + HST). This would result in an adjusted claim of **\$41,211.50** rather than \$45,116.20.

We trust the foregoing proposal appropriately anticipates and addresses any concerns that Union Gas or the Board may have.


