Ontario Energy Board File No. EB-2016-0270 Enbridge Gas Distribution Inc. ("EGD" or the "Company") Application for **Exemption from the Affiliate Relationships Code ("ARC") for Gas Distributors**

We are writing to request that the OEB amend its Order in the above noted matter. In the Order, the OEB ordered:

"Enbridge Gas Distribution Inc. is exempt from section 2.2.4 of the Affiliate Relationships Code for Gas Utilities with respect to the provision of Control Services (as that term is defined in the application) to wind farms operated by Enbridge Inc. within the Province of Ontario where those wind farms are operating under a contract with the Independent Electricity System operator, subject to the Wind Farm Conditions listed in this Decision and Order".

Enbridge Gas Distribution Inc. ("EGD") has been providing Control Services to windfarms that operate outside of Ontario since 2011 pursuant to the OEB's order in EB-2010-0232 that EGD is exempted from section 2.2.4 of the Affiliate Relationships Code ("ARC") in respect of the Control Services rendered to its affiliated wind farms (subject to the Wind Farm Conditions listed therein). At Exhibit I, Tab 2, Schedule 4 of that proceeding (EGD's response to CME interrogatory #4), EGD was asked to identify any other planned wind farm operations. EGD advised that Enbridge Inc. had another wind farm under construction in Colorado that was expected to be commissioned in October 2011 and that Enbridge Inc. was continuing to seek new wind energy investments as part of its overall corporate strategy, both in Canada and the United States.

Additionally, pursuant to the Wind Farm Conditions in EB-2010-0232, EGD has been filing all its Control Services intercorporate service agreements with the OEB including with the windfarms operated outside of Ontario.

Currently EGD is providing Control Services to the following windfarms:

EGD therefore requests that the Board amend the Order to clarify that EGD can provide Control Services to all of its affiliated windfarms, not limited to windfarms in Ontario and suggests the following wording:

"Enbridge Gas Distribution Inc. is exempt from section 2.2.4 of the Affiliate Relationships Code for Gas Utilities with respect to the provision of Control Services (as that term is defined in the application) to wind farms operated by affiliates of Enbridge Gas Distribution Inc. subject to the Wind Farm Conditions listed in this Decision and Order".
