ORDER

UPON the application of Union Gas Limited ("Union") dated June 7, 1985 for:

1. a Regulation designating certain lands to the east of the Bickford Pool, situated in the Township of Sombra in the County of Lambton, as described in Appendix "A" and shown on Appendix "B", as a gas storage area; and

2. authority to inject gas into, store gas in and remove gas from the area to be designated, and to use the land in the said area for such purposes;

AND UPON the application having been heard at Sarnia, Ontario in the presence of counsel for Union and for B. Magder Enterprises, Dawn Petroleum Company, Marguerite Reid, Stanley Yaki and Ross Font, and Special Counsel, and Muriel Andrae representing the St. Clair Conservation Authority, Achiel Kimpe representing the Lambton Gas Storage Association and in the presence of K. A. Colebrook, R. Galarneau and C. J. Bruin representing themselves;

AND UPON the Board, in its Report dated June 13, 1986, having recommended to the Lieutenant Governor in Council that the said lands be designated as a gas storage area;

AND UPON the said lands having been so designated by Ontario Regulation 97/87, made February 20, 1987, filed February 24, 1987 and published in The Ontario Gazette on March 14, 1987;

THE BOARD ORDERS THAT:

1. Union is authorized to inject gas into, store gas in and remove gas from the area designated as a gas storage area by Ontario Regulation 97/87, and to enter into and upon the said lands and to use them for such purposes;
2. The Board's costs, including the costs of the witnesses from the Ministry of Natural Resources, shall be paid by Union as soon as these have been fixed.

Those lands in the Township of Sombra, in the County of Lambton, Province of Ontario described as follows:

- a) The southeast quarter of Lot 9, in the 13th Concession, containing 50 acres more or less;
- b) The south half of Lot 10, in Concession XIII, containing 100 acres more or less;
- c) The east half of Lot 9, in Concession XII, containing 100 acres more or less;
- d) Lot 10 in Concession XII, containing 200 acres more or less;
- e) The northeast quarter of Lot 9, in Concession XI, containing 50 acres more or less;
- f) The north half of Lot 10 in Concession XI, containing 100 acres more or less;
- g) All that part of the allowance for Concession Road between Concessions XII and XIII of the said Township of Sombra, bounded on the west by the continuation in a straight line northerly of the half lot line in Lot 9, in Concession XII of the said Township of Sombra from the southerly limit of the said allowance for Concession Road to the northerly limit thereof and bounded on the east by the continuation in a straight line northerly of the easterly limit of Lot 10 in Concession XII of the said Township of Sombra from the southerly limit of the said allowance for Concession Road to the northerly limit thereof.
- h) All that part of the allowance for Concession Road between Concessions XI and XII of the said Township of Sombra, bounded on the west by the continuation in a straight line northerly of the half lot line in Lot 9, in Concession XI of the said Township of Sombra from the southerly limit of the said allowance for Concession Road to the northerly limit thereof and bounded on the east by the continuation in a straight line northerly of the easterly limit of Lot 10 in Concession XI of the said Township of Sombra from the southerly limit of the said allowance for Concession Road to the northerly limit thereof.
