**IDENTITY OF THE INTERVENOR AND ITS MEMBERSHIP**

1. The Vulnerable Energy Consumers Coalition (VECC) hereby expresses its intention to intervene and participate in the above-mentioned proceeding. VECC consists of the following organizations:

2. 9. To mitigate costs VECC requests only electronic copies of the materials. VECC may request paper copies of some or all of the materials should this become necessary. ### **GROUNDINGS FOR THE INTERVENTION**

10. The Applicant is seeking to increase the rates to customers represented by, or of similar interests, to those represented by VECC and by the associations affiliated with VECC. VECC is especially concerned with the ability of low income consumers to meet energy costs which on an annual basis continually exceed the rate of inflation.

### **INTERESTS OF THE INTEVENOR**

11. VECC was an intervenor the generic application for Community Expansion EB-2016-0004. As noted by EGD this application is made subsequent to, and in consideration of, that decision. VECC was also a party to a similar Community Expansion proceeding for Union Gas Limited – EB-2015-0179. On August 10, 2017 the Board rendered its decision in that proceeding. That decision builds upon and clarifies the implementation of EB-2016-0004. It is VECC's interest in this application to understand and test the Applicant's application of the Board's new policies for Community System expansion.
12. VECC expects to critically review all aspects of this application to ascertain if they are, in our view, in the public interest.
13. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of natural gas are fully represented in the determination of just and reasonable rates.

### **INTENTION TO SEEK COST AWARDS**

14. VECC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
15. VECC's members do not have access to the direct funding required to retain appropriate legal and consulting support for its intervention in OEB proceedings. Accordingly VECC relies on PIAC to provide legal support and retain qualified consultants on the basis that PIAC can recover the related fees and disbursements from the Board based on the Board's Practice Direction on Cost Awards at the prevailing Cost Award Tariff.
