The Ontario Energy Board (OEB) expects to release the combined Decision and Order that addresses the public portions of the 2017 Cap and Trade Compliance Plans for Enbridge Gas Distribution Inc., Union Gas Limited, Natural Resource Gas Limited (the Gas Utilities) on Thursday, **September 21 2017** after 4:00 p.m. Separate Decisions pertaining to strictly confidential matters of each gas utility will be provided to that gas utility only.

The OEB will be making copies of the Decisions available to the appropriate parties for confidential review prior to their release. To ensure a fair approach, the OEB will allow all parties to the EB-2016-0300 (EGD) / EB-2016-0296 (Union) / EB-2016-0330 (NRG) proceedings the opportunity to participate in an advance reading of the Decision that pertains to evidence that was placed on the public record. The Decisions dealing with strictly confidential matters will only be made available to each of the affected Gas Utilities.

The lock-up will commence at 3:00 p.m. on September 21, 2017. Any individuals granted early access to the Decision that will address matters on the public record will be required to remain in their assigned room until that Decision is released publicly. The use of cellular phones or other external communications devices will not be permitted during the lock- up.

Please include the names of all individuals who will attend and the organization they represent. All attendees will be required to sign in.

**To participate in the lock-up, please go to the 25<sup>th</sup> floor, 2300 Yonge Street, Toronto, Ontario by 3 p.m. on Thursday September 21, 2017.** If you arrive after 3:00 p.m., please go to the OEB reception on the 27<sup>th</sup> floor and inform the receptionist that you are there to attend the lock-up for the 2017 Cap and Trade Compliance Plan Decision. You will be directed to the appropriate area.

Should the release date change, all parties to the EB-2016-0300 (EGD) / EB-2016-0296 (Union) / EB-2016-0330 (NRG) proceeding will be notified by e-mail.
