In its Decision and Interim Orders dated March 23, 2017<sup>1</sup> and June 27, 2017<sup>2</sup>, the OEB approved Enbridge's applications approving or fixing rates for the sale, distribution, transmission, and storage of gas effective April 1, 2017 and July 1, 2017 respectively. The OEB has noted typographical errors in the aforementioned Decision and Interim Orders. Pursuant to its powers under Rule 41.02 of the OEB's Rules of Practice and Procedure, the OEB may at any time, without notice or a hearing of any kind, correct a typographical error, error of calculation or similar error made in its orders or decisions.
