The Ontario Energy Board (OEB) received ENWIN Utilities Ltd. and Essex Powerlines Corporation's Joint Application for Elimination of Load Transfer Arrangements on September 27, 2017. The OEB has assigned file number EB-2017-0304 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.
