**Re: Application for Amendment to Electricity Generation Licence
2225228 Ontario Inc. (EG-2015-0047)**

We are counsel for 2225228 Ontario Inc. (the "Corporation"), Concord Alfred GP1 Ltd. ("GP1"), and Concord Alfred Partnership (the "Partnership").

The Corporation is the licensee under Electricity Generation Licence EG-2015-0047 (the "Licence"). The Corporation intends to transfer all of its assets, including the Licence, to the Partnership. The Corporation and GP1 are the general partners of the Partnership and both entities are (and, following the proposed transfer of the Licence, will continue to be) owned by the same entity.

The Corporation is seeking an amendment to change the licensee of the Licence from '2225228 Ontario Inc.' to '**Concord Alfred Partnership**'.

- Filed partnership registration for Concord Alfred Partnership;

Such corporate organization information is treated as confidential by the Board when included in an application for an Electricity Generation Licence, and we request that the same treatment be applied to this application which is to simply amend the name of the licensee for this Licence.

Included with this application is an envelope containing the documents which we request be held confidential.

Request to Dispose without a Hearing

We request that this proceeding be disposed of without a hearing as outlined in section 21(4)(b) of the *Ontario Energy Board Act, 1998*. Section 21(4)(b) states that the Board may dispose of a proceeding provided that:

no person, other than the applicant, appellant or licence holder will be adversely affected in a material way by the outcome of the proceeding and the applicant, appellant or licence holder has consented to disposing of a proceeding without a hearing.

The outcome of this proceeding will not adversely affect any person, including the applicant and Licence holder, since the amendment to the Licence is an administrative change, rather than a substantive change. The Partnership, the Corporation, and GP1 consent to disposing of this proceeding without a hearing. The requested amendment poses no material impact to the electrical system or customers.
