**Re: Enbridge Gas Distribution Inc. ("Enbridge")
2017 Cap and Trade Compliance Plan ("Application")
Ontario Energy Board ("Board") File Number EB-2016-0300
Draft Rate Order Updated Appendix A**

Further to Enbridge Gas Distribution's ("EGD") submission of the Draft Rate Order on October 5, 2017, enclosed please find the following updated exhibit (rate schedules).

Within the Rate Handbook Rate Schedules, the indicated effective date of October 1, 2017 is appropriate for all charges other than those displayed for the Cap and Trade Customer and Facility Related Charges within the rate schedules.

As a result of the Board's EB-2016-0030 Decision, the Cap and Trade related charges shown in the Rate Schedules now become effective as of January 1, 2017. The Board previously approved EGD's Cap and Trade charges for 2017 on an interim basis within the EB-2016-0296/EB-2016-0300/EB-2016-0330, Interim Rate Order dated November 24, 2016. There is no change between the previously approved interim and final approved EGD Cap and Trade charges.

However, all of the other charges shown in the Rate Schedules are the most recent approved by the OEB within EGD's EB-2016-0215/EB-2017-0281, 2017 Rate Proceeding and October 1, 2017 Quarterly Rate Adjustment Proceeding.

To assist in the interpreting of the appropriate effective date of the charges within the Rate Schedules, EGD is providing Updated Rate Schedules within the Draft Rate Order Appendix A, which now include a "Note" which indicates the different effective dates of the charges resident in the Rate Schedules.

Enbridge notes that Board Staff and Intervenor are able to provide comments on the draft Rate Order and Accounting Orders, by October 19, 2017.

Enbridge requests that the Board review and approve the draft Rate Order and draft Accounting Orders as they follow the Board's directions in the EB-2016-0300 Decision. Enbridge respectfully requests a Board Decision on these items by Friday October 27, 2017, so that 2017 rates can be considered final approved rates for purposes of financial reporting.
