# NOTICE OF INTERVENTION OF THE VULNERABLE ENERGY CONSUMERS COALITION

#### **IDENTITY OF THE INTERVENOR AND ITS MEMBERSHIP**

- 1. The Vulnerable Energy Consumers Coalition (VECC) hereby expresses its intention to intervene and participate in the above-mentioned proceeding. VECC consists of the following organizations:
  - (a) The Federation of Metro Tenants Association (FTMA)
  - (b) The Ontario Coalition of Senior Citizens' Organizations (OCSCO)
- 2. The Federation of the Metro Tenants Association (the "FTMA") is a non-profit corporation composed of over ninety-two affiliated tenants associations, individual tenants, housing organizations, and members of non-profit housing co-oops. In addition to encouraging the organization of tenants and the promotion of decent and affordable housing, the Federation provides general information, advice, and assistance to tenants. 3. The Ontario Coalition of Senior Citizens' Organizations ("OCSCO") is a coalition of over 160 senior groups as well as individual members across Ontario. The coalition of the FMTA and OCSCO under the name VECC has the specific mandate of intervening in proceedings to advocate on behalf of the interests of Ontario's vulnerable consumers with respect to energy issues, primarily through intervention in regulatory proceedings at the Ontario Energy Board.

- 5. Although the organization is not itself a member of VECC, the Public Interest Advocacy Centre (PIAC) in Ottawa assists in the representation of the interests of vulnerable consumers by ensuring the availability of competent representation and consultant support to the VECC participation.

#### **GROUNDS FOR THE INTERVENTION**

10. The Applicant is seeking to increase the rates to customers represented by, or of similar interests, to those represented by VECC and by the associations affiliated with VECC. VECC is especially

concerned with the ability of low income consumers to meet energy costs which on an annual basis continually exceed the rate of inflation.

#### INTERESTS OF THE INTEVENOR

- 11. Enbridge Gas Distribution Inc. (EGD) VECC was an intervenor multi-year (2014-18) Custom IRM application EB-2012-0459 of Enbridge Gas Distribution. Most recently VECC was a party to EB-2016-0215, the 2017 IRM rate setting proceeding under the approved rate plan.
- 12. VECC's interests are to see that the implementation of rates is in accordance with the Board approved agreement. Specifically VECC intends to scrutinize the following items natural gas volumes, revenues, gas supply plan, pension and other post-employment benefits, income taxes, and cost of debt. VECC expects to critically review all aspects of this application to ascertain if they are, in our view, in the public interest.
- 13. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of natural gas are fully represented in the determination of just and reasonable rates.

## **INTENTION TO SEEK COST AWARDS**

- 14. VECC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
- 15. VECC's members do not have access to the direct funding required to retain appropriate legal and consulting support for its intervention in OEB proceedings. Accordingly VECC relies on PIAC to provide legal support and retain qualified consultants on the basis that PIAC can recover the related fees and disbursements from the Board based on the Board's Practice Direction on Cost Awards at the prevailing Cost Award Tariff.
