

ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF LAKEFRONT UTILITIES INC.

Lakefront Utilities Inc. applied to raise its electricity distribution rates effective January 1, 2018.

Lakefront Utilities Inc. applied to the Ontario Energy Board to raise its electricity distribution rates effective January 1, 2018. If the application is approved, a typical residential customer of Lakefront Utilities Inc. would see an increase of approximately \$0.83 per month. Other customers, including businesses, may also be affected.

The requested rate increase is set using an OEB-approved formula which is tied to inflation and other factors intended to promote efficiency. The rate increase also includes Lakefront Utilities Inc.'s request to refund to customers a balance in an account.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Lakefront Utilities' request. We will determine whether the company has used the applicable models and formulas required by the OEB. We will also hear questions and arguments from individual customers and from groups that represent Lakefront Utilities' customers. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review Lakefront Utilities' application on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **October 29, 2017** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, you can review the OEB's decision and its reasons on our website.

The OEB does not intend to provide for an award of costs for this hearing.

ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. The OEB intends to proceed by way of a written hearing in this case. If you think an oral hearing is needed, you can write to the OEB to explain why by **October 29, 2017**.

PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This rate hearing will be held under section 78 of the Ontario Energy Board Act, S.O. 1998 c.15 (Schedule B).
