(“Hydro One”) transmission assets and facilities proposed for upgrading in this Application. As such, NextBridge has significant interest in the Application and proceeding.

NextBridge reserves the right to be heard in English, to appear by or with counsel of its choice, to clarify or test evidence through interrogatories, to cross-examine on all subject matters in this proceeding that may relate to its interests, to adduce evidence on specific matters that are relevant to these proceedings, and to present argument.
