

ONTARIO ENERGY BOARD NOTICE

Union Gas Limited has applied to renew its natural gas franchise agreement with the Corporation of the Municipality of Calvin.

Union Gas Limited has applied to the Ontario Energy Board for:

1. The renewal of a natural gas franchise agreement with the Corporation of the Municipality of Calvin which would grant to Union Gas Limited the right to build, operate and add to the gas distribution system and to distribute, store and transmit natural gas for a period of 20 years.
2. An order that the agreement of the municipal voters of the Corporation of the Municipality of Calvin is not required in relation to renewing the natural gas franchise agreement.
3. An order cancelling the existing certificate of public convenience and necessity held by Union Gas Limited for the Township of Calvin and replacing it with a certificate of public convenience and necessity for the Corporation of the Municipality of Calvin.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Union Gas' requests. At the end of this hearing, the OEB will decide whether to grant Union Gas' requests.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

CERTIFICATES OF PUBLIC CONVENIENCE AND NECESSITY

In order to distribute natural gas in Ontario, a person must comply with the requirements of the *Municipal Franchises Act*. This Act requires that a person that intends to distribute natural gas within a municipality must first receive approval from the OEB, in the form of a certificate of public convenience and necessity. Where the OEB has issued a certificate for an area but there is currently no natural gas distribution service, another person can apply for a certificate to serve that area.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by Union Gas on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **February 6, 2018** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, review the OEB's decision and its reasons on our website.

The OEB does not intend to provide for an award of costs for this hearing.

There are two types of OEB hearings – oral and written. The OEB intends to proceed with this application by way of a written hearing. If you think an oral hearing is needed, you can write to the OEB to explain why by **February 6, 2018**.

PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.
