Pursuant to the Board’s Decision and Order dated September 21, 2017, Enbridge Gas Distribution provides the following in response to comments submitted by BOMA on the Draft Rate and Accounting Orders EGD filed on October 5, 2017 and updated on October 18, 2017.

EGD understands the comments from BOMA indicating that additional wording description could be included to assist in interpreting a definition of Cap and Trade charges and whether they are subject to certain riders.

With further time required to review such wording considerations, EGD proposes to consider potential additional wording which could address BOMA’s comments for inclusion into EGD’s next EB-2017-0086, 2018 Rate Proceeding and Draft Rate Order and associated rate schedules which are scheduled to be produced and approved by December 15, 2017.
