Order

LunarLight LP (LunarLight) and St. Columban Wind GP Inc., on behalf of St. Columban Wind LP (St. Columban Wind) each filed an application on September 19, 2017 with the Ontario Energy Board (OEB), under section 74 of the *Ontario Energy Board Act, 1998* (OEB Act) to amend their electricity generation licences EG-2014-0212 and EG-2014-0148, respectively.

On October 24, 2017, BluEarth Asset Management Inc. (BluEarth) filed an application with the OEB under section 74 of the OEB Act to amend its electricity generation licence EG-2014-0200.

The OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act.

LunarLight is the current owner and operator of LunarLight Solar Park generation facility under the authority of its licence EG-2014-0212. LunarLight requested to amend Schedule 1 of its licence such that it will no longer be the operator of LunarLight Solar Park generation facility.

St. Columban Wind is the current owner and operator of St. Columban 1 Energy Project and St. Columban 2 Energy Project generation facilities under the authority of its licence EG-2014-0148. St. Columban Wind requested to amend Schedule 1 of its licence such that it will no longer be the operator of these generation facilities.

BluEarth requested to amend Schedule 1 of its licence EG-2014-0200 to become the operator of LunarLight Solar Park, St. Columban 1 Energy Project and St. Columban 2 Energy Project generation facilities.

The applications have been considered without holding a hearing pursuant to section 6(4) of the OEB Act.

IT IS ORDERED THAT:

1. LunarLight LP's electricity generation licence EG-2014-0212 is amended in accordance with the attached revised licence.

2. St. Columban Wind GP Inc., on behalf of St. Columban Wind LP's electricity generation licence EG-2014-0148 is amended in accordance with the attached revised licence.
3. BlueEarth Asset Management Inc.'s electricity generation licence EG-2014-0200 is amended in accordance with the attached revised licence.
