Re: Applications for approval of 2017 Cap and Trade Compliance Plan cost consequences (Union Gas Limited, Enbridge Gas Distribution Inc. and Natural Resource Gas Limited) Association of Power Producers of Ontario ("APPrO") - Cost Claim Board File No. EB-2016-0296/EB-0216-0300/EB-2016-0330

Please find attached the Cost Claim (along with attached invoices and receipts) submitted by APPrO in relation to the above noted combined proceeding.

APPrO participated responsibly in this proceeding, limiting its involvement to matters of direct concern to its members that are Rate 125 customers of Enbridge Gas Distribution Inc. ("Enbridge") and gas-fired generators who contract for distribution and transportation services within the Union Gas Limited ("Union") North and South franchise areas under several rate classes, including Rate T2, Rate 20, Rate 100 and Rate M12. APPrO has no members that are affected by the Natural Resource Gas Limited application. Consequently, APPrO limited the scope of its submissions to the Enbridge and Union applications.

APPrO filed interrogatories to Enbridge and Union, participated in the oral hearing, including coordinating interrogatories and cross-examination with other intervenors to minimize duplication and maximize efficiency of the hearing process, and filed written submissions with the Board in this matter.

The applications for approval of 2017 Cap and Trade Compliance Plan cost consequences were the first to be presented to the Board. As such, they raised a number of public policy issues which necessitated involvement of different professionals with relevant expertise, all of which contributed to the preparation of APPrO's argument and submissions in this combined proceeding.

APPrO focused its efforts on rate predictability: whether the proposed deferral and variance accounts were reasonable and appropriate and whether the disposition methodology was



appropriate and consistent with the Board's *Regulatory Framework for the Assessment of Costs of Natural Gas Utilities' Cap and Trade Activities*, EB-2015-0363 dated September 26, 2016. At page 36 of its Decision and Order in this proceeding, the Board made reference to APPrO's submissions that the Board determine parameters setting out how the GHG variance accounts will be disposed of to ensure rate predictability and avoid adverse impacts on Ontario's electricity markets. The Board found that the disposition amounts and methods will be determined in the 2019 Compliance Plan proceeding where the accounts will be examined in the context of the cap and trade program rather than utility DVA applications, deferring the decision on disposition to allow for more time and information to consider the issues.

APPrO has at all times complied with the Board's orders, rules, codes, guidelines, filing requirements, Rule 22 of the Board's Rules of Practice and Procedure and Rule 3.03.1 of the Board's Practice Direction on Cost Awards, and with all directions of the Board. APPrO also made reasonable efforts to co-operate with other parties on issues of common concern. Finally, APPrO made reasonable efforts to ensure that its participation in the process, including its interrogatories, was not unduly repetitive and was focused on relevant and material issues.

Accordingly, APPrO respectfully requests that the Board confirm that it will be permitted to recover its Cost Claim as submitted.
