

As a result, a second sampling event was conducted and the triad approach was once again applied. The results formed the basis of a detailed quantitative risk assessment (DQRA) conducted at the site. The results once again suggested no risks to human or ecological health.

In support of the environmental assessment process in Ontario, screening level human health and ecological risk assessments were conducted for two sites that were planned for redevelopment in order to house new power generating facilities. The assessment included the quantitative modeling of deposition and subsequent exposure of both humans and ecological receptors to emissions from the power plants. No unacceptable risks were found.

A quantitative ecological risk assessment was carried out at a former bulk plant property in Eastern Canada due to the presence of benzene, toluene, ethylbenzene, and xylenes and petroleum hydrocarbons in soil and groundwater on the site. Potential risks to both the terrestrial habitat on-site and the aquatic habitat in the adjacent river were quantified.
