**Re: EB-2017-0306 – Enbridge Gas Distribution Inc. (“Enbridge”) and Union Gas Limited (“Union”) – MAAD Application – Request for Intervention by Rover Pipeline LLC (“Rover”)**

We act as counsel to Rover in respect of the above matter. Pursuant to the letter of direction issued by the Ontario Energy Board (“Board”) on December 1, 2017, Rover is writing to formally request intervenor status in Board proceeding EB-2017-0306 (“Proceeding”).

Rover is a limited liability company incorporated under the laws of the United States. Rover is in the process of constructing pipeline infrastructure to transport natural gas from processing plants in West Virginia, Eastern Ohio and Western Pennsylvania for delivery to the Dawn Hub in Ontario. Rover’s facilities connecting to the Dawn Hub are expected to be in-service in 2018. Rover also ships natural gas and holds a C1 Transportation Contract on Union’s natural gas transmission system. As a transporter of natural gas into the Ontario market and a shipper on Union’s system, Rover has a directly affected interest in the proposed amalgamation between Enbridge and Union effective January 1, 2019.

Rover would reserve its right to be heard in English, to appear by or with counsel, and to participate in all aspects of the Proceeding including evidence, interrogatories, cross-examination, and argument.

Rover does not expect to seek cost awards for the Proceeding.


