The Ontario Energy Board (OEB) received Veridian Connections Inc. and Hydro One Networks Inc.'s joint application for elimination of load transfer arrangements on December 19, 2017. The OEB has assigned file number EB-2017-0378 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

For these purposes, OEB staff may contact you by email, regular mail, or by telephone. Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days.

The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
