

ONTARIO ENERGY BOARD NOTICE

OM Limited Partnership has applied for the right to supply natural gas to the Maricann Langton Facility in the Township of North Walsingham, Norfolk County.

OM Limited Partnership (made up of ON Energy Corp. and Maricann Group Inc.) has applied to the Ontario Energy Board for a certificate of public convenience and necessity which would give it the right to construct facilities and supply natural gas to the new Maricann Group Inc. Langton Facility located in Langton, Ontario.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider OM Limited Partnership's request. At the end of this hearing, the OEB will decide whether to grant OM Limited Partnership's request.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

MUNICIPAL FRANCHISE AGREEMENTS & CERTIFICATES OF PUBLIC CONVENIENCE AND NECESSITY

In order to distribute natural gas in Ontario, a person must comply with the requirements of the *Municipal Franchises Act*. This Act requires that a person that intends to distribute natural gas within a municipality must first receive approval from the OEB, in the form of a certificate of public convenience and necessity. Where a certificate has been issued for an area but there is currently no distribution service, another person can apply for a certificate to serve that area.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review the application filed by OM Limited Partnership on the OEB's website now.
- You can file a letter with your comments, which will be considered during the hearing.
- You can become an active participant (called an intervenor). Apply by **January 29, 2018** or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- At the end of the process, review the OEB's decision and its reasons on our website.

The OEB does not intend to provide for an award of costs for this hearing.

ORAL VS. WRITTEN HEARINGS

There are two types of OEB hearings – oral and written. OM Limited Partnership has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why by **January 29, 2018**.

PRIVACY

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.

This hearing will be held under section 8 of the Municipal Franchises Act, R.S.O. 1990, c.M.55.
