Union Gas Limited

Application for licences to drill three natural gas storage wells and leave to construct a natural gas pipeline in the Bickford designated storage area in the Township of St. Clair in the County of Lambton

PROCEDURAL ORDER NO. 1 January 26, 2018

Union Gas Limited (Union Gas) filed an application dated December 7, 2017 with the Ministry of Natural Resources and Forestry (MNRF) for three well drilling licences in the Bickford designated storage area (Bickford Pool). The application was referred to the Ontario Energy Board (OEB) by the MNRF on December 8, 2017, pursuant to section 40(1) of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15 (schedule B) (OEB Act).

Union Gas has also applied under section 90 of the OEB Act for leave to construct approximately 530 metres of 12 inch diameter natural gas pipeline within the Bickford Pool.

The OEB issued a Notice of Hearing on January 4, 2018, which was served and published as directed.

Enbridge Gas Distribution Inc. (Enbridge Gas) and the MNRF applied for intervenor status. Union Gas did not file any objection.

Intervenor status is granted to each of Enbridge Gas and the MNRF. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- OEB staff and intervenors shall request any relevant information and documentation from Union Gas that is in addition to the evidence already filed by written interrogatories filed with the OEB and served on all parties by February 9, 2018.
- Union Gas shall file with the OEB complete written responses to all interrogatories and serve them on all intervenors and OEB staff by February 21, 2018.
- 3. Unless the OEB orders otherwise, OEB staff and intervenors may file any written submission with the OEB and serve them on all parties by **March 5**, **2018**.
- 4. Unless the OEB orders otherwise, Union Gas may file a written reply submission with the OEB and serve it on all intervenors and OEB staff by March 12, 2018.

All filings to the Board must quote the file number, EB-2017-0363 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at https://pes.ontarioenergyboard.ca/eservice/. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at https://www.oeb.ca/industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
