RE: File Number EB-2015-0304 - Review of Miscellaneous Rates and Charges - Draft Report of the Board - Framework for Determining Wireline Pole Attachment Charges - Comments of Quebecor Media Inc. (Quebecor Media) on behalf of its affiliate Videotron Ltd¹ (Videotron)

- By way of this letter, Quebecor Media, on behalf of Videotron, hereby responds to the Board's call for submissions issued on 18 December 2017 regarding its draft report (the Draft Report) setting out a policy for the wireline pole attachment rates charges by local distribution companies (LDCs) for the attachments of telecommunication and cable companies to distribution poles.
- 2. As a general comment, Quebecor Media is greatly concerned by the fact that a review exercise initially launched with the core objective of reviewing the methodology for setting the wireline pole attachment rate and to be carried out by a working group composed of a limited number of stakeholders has resulted, most notably, in a proposal to radically increase the current province-wide wireline pole attachment rate from \$22.35 per pole per year to \$52.00 per pole per year.
- 3. On a more specific level, Quebecor Media has had the opportunity to review the comments and supporting reports filed by Rogers Communications Canada Inc. (Rogers) in response to the Board's call for submissions. We submit that the numerous

methodological failings in the Draft Report, as identified by Rogers, are sufficiently serious as to call into question its usefulness as an element of the Board's decision making process.

- 4. Quebecor Media therefore wholeheartedly supports Rogers' comments and urges the Board not to proceed with the recommendations put forth in the Draft Report. In our opinion, a more appropriate course of action for the Board would be to either:
 - adjust the current province-wide attachment rate of \$22.35 per pole per year (in place since 2005) for twelve years of inflation; or
 - hold a full, fair and proper hearing focussed on the review of the current provincewide attachment rate of \$22.35 per pole per year.
- 5. Trusting this is satisfactory, we remain,
