PROCEDURAL ORDER NO. 1

February 13, 2018

OM Limited Partnership (OMLP) filed an application with the Ontario Energy Board (OEB) on August 24, 2017 under section 8 of the *Municipal Franchises Act, 1990* for an order granting OMLP a certificate of public convenience and necessity to construct facilities and supply natural gas to the new Maricann Group Inc. Langton Facility located in Langton, Ontario.

The OEB issued a Notice of Hearing on January 10, 2018. The last date for intervention was January 29, 2018. Pursuant to the Notice of Hearing, Union Gas Limited (Union Gas) applied for intervenor status.

No objection was received from OMLP.

Union Gas is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

- Union Gas and OEB staff shall request any relevant information and documentation from OMLP that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on OMLP by February 23, 2018.
- 2. OMLP shall file with the OEB complete responses to all interrogatories and serve them on Union Gas by **March 9, 2018.**
- Unless the OEB orders otherwise, Union Gas and OEB staff may file any written submission with the OEB and serve them on OMLP by March 16, 2018.
- 4. Unless the OEB orders otherwise, OMLP may file a written reply submission with the OEB and serve it on Union Gas by **March 23, 2018**.

All filings to the OEB must quote the file number, EB-2017-0289 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <u>https://pes.ontarioenergyboard.ca/eservice/</u>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>https://www.oeb.ca/industry</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
