ONTARIO ENERGY BOARD IN THE MATTER OF The Ontario Energy Board Act, R.S.O. 1970, Chapter 213, Sections 12, 24 and 31; AND IN THE MATTER of an application by Bracell Petroleums Limited for an Order designating Murphy Oil Company Ltd. as the Manager of the West Becher pool unit operation in the place of Bralorne Oil & Gas Limited 5

APPLICATION

- 1. Bracell Petroleums Limited, hereinafter called the Applicant, is a corporation incorporated under the Laws of the Province of Alberta having its head office at the City of Calgary, in the Province of Alberta.
- 2. An Order-in-Council dated April 17, 1963, a regulation made under the Energy Act (as it then was) joined the interest of persons in the West Becher pool as listed in Schedule "C" to the form of unit operation agreement attached to and forming part of the said regulations for the purposes of drilling and operating wells and designated Imperial Oil Limited as the Manager of the said unit operation.
- By Order of the Ontario Energy Board under Docket No. E.B.O.45 dated August 24, 1971, Imperial Oil Limited was replaced as operator of the said unit operations by Bralorne Oil & Gas Limited.
- 4. On June 5th, 1972, pursuant to its governing legislation, Bralorne Oil and Gas Limited changed its name to Bracell Petroleums Limited.

- 5. Murphy Oil Company Ltd., a company incorporated pursuant to the Laws of the Province of Alberta, having its head office in the City of Calgary, in the Province of Alberta, hereinafter called Murphy Oil, is the sole beneficial owner of all of the issued and outstanding shares of the Applicant. By way of Agreement dated January 1, 1974, the applicant and Murphy Oil entered into an Agreement providing for the dissolution and liquidation of the Applicant and the conveyance of all of the assets of the applicant to its sole shareholder, Murphy Oil Ltd. The transfer of assets and assumption of liabilities by the sole beneficial shareholder, Murphy Oil Ltd., is effective as at January 1st, 1974. As at the date of this application the Applicant has not been dissolved.
- 6. The Applicant therefore now applies to the Board by way of an application for an Order under Section 24 of the Ontario Energy Board Act varying the provisions of Order-in-Council 1087-63 dated April 17th, 1963 as amended by Order of the Ontario Energy Board E.B.O. 45 dated August 24th, 1971, by designating Murphy Oil Company Ltd. as the manager of the West Becher pool unit operation in the place of and instead of Bralorne Oil & Gas Limited.
- 7. The parties affected by this Application are those parties forming part of the West Becher pool and which persons are listed in Schedule "A" attached hereto.
