## FURTHER WITNESS STATEMENT OF

My name is and I reside in the Town of Aurora in the Province of Ontario.

- 1. In the process of preparing for this hearing, I have reviewed my previous Witness Statement dated January 11, 2017 ("January Witness Statement").
- 2. Having reviewed the January Witness Statement more closely, I wish to make the following two corrections:
  - a. At paragraph 5, it states that the same ACN IBO who had signed me up for ACN told me the correct answers for my online test. In fact, it was a different ACN IBO from my group (who still stood to benefit financially from my sales) – and not the same ACN IBO who signed me up for ACN.
  - b. At paragraph 12, it states that I did not provide consumers with any kind of business card during our meetings. In fact, I did provide consumers with a business card during our meetings.

I did not notice these errors in the January Witness Statement during my previous reviews of that statement.

- 3. I was never told that ACN IBOs can only sell products to friends or family (although I only sold products to people who I would consider my friends).
- 4. On the "Certificate of Completion", I wrote a comment: "I did not read Product Training. None of us did." I wrote this comment when reviewing my documents (and finding the Certificate) in the course of preparing for this proceeding. By "none of us", I was referring to other ACN IBOs that I knew who signed up around the same time that I did. I knew that they did not read the "Product Training" in any detail because we spoke about the process of going through the steps to start selling energy contracts.

- 5. I have reviewed the "Updated Q1 Document"2 and compared it with the customer details available on my ACN "back office" website (a printout of which is included at Tab "A" to this Witness Statement)3. The latter includes only currently "active" accounts (and thus I believe excludes accounts where the contract has come to an end).
- 6. Based on my review of these documents, it appears there are inaccuracies and missing information in the Updated Q1 Document. By way of example, I did not enrol into any energy contracts, nor do I know anyone by that name.
- 7. I am not in a position to explain all of the discrepancies between the Updated Q1 Document and Tab "A", but I believe Tab "A" is an accurate listing of such currently active accounts.
