Sarnia Airport Storage Pool Limited Partnership

Application for approval to increase the maximum operating pressure of the Sarnia Airport Natural Gas Storage Pool in the City of Sarnia in the County of Lambton

PROCEDURAL ORDER NO. 1 March 8, 2018

Sarnia Airport Storage Pool Limited Partnership (SASP) filed an application with the Ontario Energy Board (OEB) on December 17, 2017, for approval to increase the operating pressure of the Sarnia Airport Natural Gas Storage Pool to 17.2 kPa/m (0.76 psi per foot). If approved, the new operating pressure will be higher than the operating pressure of 16.5 kPa/m (0.73 psi per foot) previously approved by the OEB. An increase in operating pressure will increase the deliverability of the Sarnia Airport Natural Gas Storage Pool.

The OEB issued a Notice of Hearing on January 31, 2018. The Ministry of Natural Resources and Forestry (MNRF) applied for intervenor status. SASP did not file any objection. Intervenor status is granted to MNRF. The list of parties in this proceeding is attached as Schedule A to this procedural order.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and MNRF shall request any information and material from SASP that is in addition to SASP's evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to SASP by **March 19, 2018**.
2. SASP shall file with the OEB complete written responses to all interrogatories and deliver them to MNRF by **March 29, 2018**.

3. Unless the OEB orders otherwise, OEB staff and MNRF may file any written submission with the OEB and deliver them to all parties by **April 9, 2018**.
4. Unless the OEB orders otherwise, SASP may file a written reply submission with the OEB and deliver it to all parties by **April 19, 2018**.

All filings to the Board must quote the file number, EB-2017-0362 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
