Re: Application for Electricity Generation Licence

Please find enclosed an application for an Electricity Generation Licence for the Nanticoke Solar Limited Partnership (the "Partnership") as required under sections 57(c), 57(f), and 60 of the *Ontario Energy Board Act, 1998*.

The Partnership was formed between Ontario Power Generation Inc. ("OPG"), Nanticoke Solar Inc., and 9374264 Canada Limited Corporation ("First Nations") – a corporation that is wholly owned by Six Nations First Nation – to undertake the development, construction, ownership and operation of Nanticoke Solar Generating Station. Subject to the limited partnership agreement for Nanticoke Solar LP, the general partner of the Partnership is Nanticoke Solar Inc. and the limited partners are OPG and First Nations. The Partnership is seeking a licence to generate and sell electricity as the owner and operator of a 44-MW Solar (Photovoltaic) generating station known as Nanticoke Solar Generating Station.
