**Enbridge Gas Distribution Inc.**

**Application for leave to construct a natural gas pipeline in the Town of Scugog  
and to charge a system expansion surcharge in respect of the project**

**PROCEDURAL ORDER NO. 1**

**March 21, 2018**

On December 15, 2017, Enbridge Gas Distribution Inc. (Enbridge Gas) applied to the OEB under s. 36, s. 90, and s. 97 of the *Ontario Energy Board Act, 1998* for approvals that would allow Enbridge Gas to provide natural gas service to the community of Scugog Island, in the Town of Scugog, in the Regional Municipality of Durham (Scugog Island Project).

A Notice of Hearing was issued on January 26, 2018. The OEB did not receive any requests for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff shall request any information and material from Enbridge Gas that is in addition to Enbridge Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Enbridge Gas by **April 4, 2018**.
2. Enbridge Gas shall file with the OEB complete written responses to all interrogatories by **April 18, 2018**.
3. Unless the OEB orders otherwise, OEB staff may file a written submission with the OEB and deliver it to Enbridge Gas by **May 2, 2018**.

4. Unless the OEB orders otherwise, Enbridge Gas may file a written reply submission with the OEB by **May 16, 2018**.

All filings to the OEB must quote the file number, EB-2017-0261 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed at the OEB's address provided below. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
