Union Gas Limited

**Application for leave to construct a natural gas transmission pipeline and
associated facilities in Oxford County and Norfolk County**

PROCEDURAL ORDER NO. 1

March 22, 2018

On January 16, 2018, Union Gas Limited (Union Gas) applied to the Ontario Energy Board (OEB) under s. 90(1) of the *Ontario Energy Board Act, 1998* for an order granting leave to construct approximately 5.2 kilometre natural gas transmission pipeline in the Counties of Oxford and Norfolk (Oxford Reinforcement Project).

The OEB issued a Notice of Hearing on February 7, 2018. The OEB did not receive any requests for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. The OEB may issue further procedural orders from time to time.

IT IS THEREFORE ORDERED THAT:

1. OEB staff shall request any information and material from Union Gas that is in addition to Union Gas' evidence and that is relevant to the hearing by written interrogatories filed with the OEB and delivered to Union Gas by **April 5, 2018**.
2. Union Gas shall file with the OEB complete written responses to all interrogatories by **April 19, 2018**.
3. Unless the OEB orders otherwise, OEB staff may file a written submission with the OEB and deliver it to Union Gas by **May 3, 2018**.
4. Unless the OEB orders otherwise, Union Gas may file a written reply submission with the OEB by **May 17, 2018**.

All filings to the Board must quote the file number, EB-2018-0003 and be made electronically in searchable / unrestricted PDF format through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Two paper copies must also be filed. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
