**Application for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2018.**

# 1 INTRODUCTION AND SUMMARY

Through this Decision and Order, the Ontario Energy Board (OEB) approves the incentive rate-setting mechanism (IRM) application filed by Energy+ Inc. (Energy+) on September 25, 2017, as amended during the course of the proceeding.

Energy+ serves about 65,000 mostly residential and commercial electricity customers in the City of Cambridge, the Township of North Dumfries and certain areas within the County of Brant. The company is seeking the OEB's approval for the rates it charges to distribute electricity to its customers, as is required of licenced and rate-regulated distributors in Ontario.

Cambridge and North Dumfries Hydro Inc. (Cambridge and North Dumfries Hydro) and Brant County Power Inc. (Brant County Power) amalgamated to form a consolidated entity on January 1, 2016 under the electricity distribution license Energy+ Inc.<sup>1</sup> The intention is to maintain distinct rate schedules for the two service areas until the rates are harmonized in the 2019 rate year. As part of the amalgamation agreement, Energy+ agreed not to increase the distribution rates for the Brant County Power service area rates for four years.

A distributor may choose one of three rate-setting methodologies approved by the OEB. Each of these is explained in the OEB's [Chapter 3 Filing Requirements for Incentive Rate-Setting Applications](#) (the Filing Requirements).

Energy+'s application is based on a Price Cap Incentive Rate-setting option (Price Cap IR) with a five-year term. The Price Cap IR option involves the setting of rates through a cost of service (COS or rebasing) application in the first year. Mechanistic price cap adjustments, based on inflation and the OEB's assessment of the distributor's efficiency, are then approved through IRM applications in each of the ensuing four (adjustment) years.

As a result of the OEB's findings in this Decision, there will be a monthly bill decrease of \$5.35 in the service area of the former Cambridge and North Dumfries Hydro, and of \$4.64 in the service area of the former Brant County Power, for a residential customer consuming 750 kWh, effective May 1, 2018.

Energy+ has also applied to change the composition of its distribution service rates. Residential distribution service rates currently include a fixed monthly charge and a variable usage charge. In 2015, the OEB issued a policy to transition these rates to a

fully fixed structure over a four-year period beginning in 2016.<sup>2</sup> Accordingly, the fixed monthly charge for 2018 has once again been adjusted upward in this Decision by more than the mechanistic price cap adjustment alone. The variable usage rate is commensurately lower. This policy change does not affect the total revenue that distributors collect from residential customers.

## 2 THE PROCESS

This Decision is being issued by delegated authority, without a hearing, under section 6 of the *Ontario Energy Board Act, 1998* (the OEB Act).

The OEB follows a standardized and streamlined process for IRM applications filed under Price Cap IR. In each adjustment year of a Price Cap IR term, the OEB prepares a Rate Generator Model that includes information from the distributor's past proceedings and annual reporting requirements. A distributor will then review and complete the Rate Generator Model and include it with its application. During the course of the proceeding, the Rate Generator Model will also be updated or corrected, as required.

The Rate Generator Model updates base rates, retail transmission service rates and, if applicable, shared tax saving adjustments. It also calculates rate riders for the disposition of deferral and variance account balances.

Energy+ filed its application on September 25, 2017, under section 78 of the OEB Act and in accordance with the Filing Requirements. Energy+ supported its application with written evidence and a completed rate model. Questions were asked of, and answers were provided by, Energy+ through emails and phone calls with the OEB. Based on this information, a draft decision was prepared and provided to Energy+ on March 14, 2018. Energy+ was given the opportunity to provide its comments on the draft for consideration prior to the OEB issuing this Decision.

## 3 ORGANIZATION OF THE DECISION

In this Decision, the OEB addresses the following issues, and provides reasons for approving or denying Energy+'s proposals relating to each of them:

- Price Cap Adjustment
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Residential Rate Design
- Other Matters

In the final section, the OEB addresses the steps to implement the final rates that flow from this Decision.

## 4 PRICE CAP ADJUSTMENT

Energy+ seeks to increase its rates, effective May 1, 2018, based on a mechanistic rate adjustment using the OEB-approved *inflation minus X-factor* formula applicable to Price Cap IR applications.

The components of the Price Cap IR adjustment formula applicable to Energy+ are set out in Table 4.1, below. Inserting these components into the formula results in a 0.90% increase to Energy+'s rates:  $0.90\% = 1.20\% - (0.00\% + 0.30\%)$ .

The inflation factor of 1.20% applies to all Price Cap IR applications for the 2018 rate year.

The X-factor is the sum of the productivity factor and the stretch factor. It is a

productivity offset that will vary among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income.

The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all Price Cap IR applications for the 2018 rate year.

The stretch factor component of the X-factor is distributor specific. The OEB has established five stretch factor groupings, each within a range from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The most efficient distributor would be assigned the lowest stretch factor of 0.00%. Conversely, a higher stretch factor would be applied to a less efficient distributor (in accordance with its cost performance relative to expected levels) to reflect the incremental productivity gains that the distributor is expected to achieve. The stretch factor assigned to Energy+ is 0.30%.

Energy+ applied for a price cap adjustment for its Cambridge and North Dumfries Hydro service area but not for its Brant County Power service area. The OEB approved the amalgamation of Brant County Power and Cambridge and North Dumfries Hydro effective January 1, 2016.

## Findings

The OEB finds that Energy+'s request for a 0.90% Price Cap IR adjustment for the service area of the former Cambridge and North Dumfries Hydro is in accordance with the annually updated parameters set by the OEB. The adjustment is approved, and the new rates for that area shall be effective May 1, 2018.

The adjustment applies to distribution rates (fixed and variable charges) uniformly across all customer classes.<sup>6</sup>

The OEB approves a price cap adjustment of 0.00% for the service area of the former Brant County Power for 2018 distribution rates as requested.

## 5 RETAIL TRANSMISSION SERVICE RATES

Distributors charge retail transmission service rates (RTSRs) to their customers to recover the amounts they pay to a transmitter, a host distributor or both for transmission services. All transmitters charge Uniform Transmission Rates (UTRs) approved by the OEB to distributors connected to the transmission system. Host distributors charge host-RTSRs to distributors embedded within the host's distribution system.

Energy+ is a transmission connected, partially embedded distributor in Hydro One Networks Inc. distribution system for the Cambridge and North Dumfries Hydro service area and is partially embedded in the Hydro One Networks Inc. and Brantford Power Inc. distribution system for the Brant County Power service area. Energy+ is requesting approval to adjust the RTSRs that it charges its customers to reflect the rates that it pays for transmission services included in Table 5.1, Table 5.2, and Table 5.3.

The OEB has also approved Brantford Power Inc.'s RTSRs, as shown in the following table, this is only applicable to the Brant County Power service area:<sup>9</sup>

## Findings

Energy+'s proposed adjustment to its RTSRs is approved. The RTSRs were adjusted based on the current host-RTSRs and the UTRs current at the time of the filing. The OEB finds that the new 2018 RTSRs for Brantford Power Inc. are to be incorporated into the rate model to adjust the RTSRs that Energy+ will charge its customers accordingly.

The differences resulting from the approval of the new 2018 RTSRs for Hydro One Networks Inc. will be captured in Accounts 1584 and 1586 for future disposition.

## 6 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts in order to determine whether their total balance should be disposed.<sup>10</sup> OEB policy requires that Group 1 accounts be disposed if they exceed (as a debit or credit) a pre-set disposition threshold of \$0.001 per kWh, unless a distributor justifies why balances should not be disposed.<sup>11</sup> If the balance does not exceed the threshold, a distributor may elect to request disposition.

In the OEB decision on Energy+'s 2017 IRM application<sup>12</sup>, the OEB directed Energy+ to have an external special purpose audit engagement for the period from January 1, 2015 to December 31, 2016 for Accounts 1588 Power and 1589 Global Adjustment (GA). Energy+ engaged KPMG LLP to perform the special purpose audit of accounts 1588 Power and 1589 GA. In the special purpose audit report, the opinion expressed by KPMG LLP read as follows:

In our opinion, the schedule of variance accounts 1588 and 1589 of Energy+ Inc. for the years ended December 31, 2015 and December 31, 2016 is prepared, in all material respects, in accordance with the financial reporting provisions of the Accounting Procedures Handbook for Electricity Distributors and related Frequently Asked Questions as published by the Ontario Energy Board.<sup>13</sup>

Through its review, Energy+ identified adjustments for Account 1588 representing a reallocation of costs from Account 1589 for 2015 and 2016. As part of its review, Energy+ revised its computation of the Regulated Price Plan (RPP)/Non-RPP kWh volume ratios for purposes of allocating the GA between Accounts 1588 and Account 1589. The principle reason for the change was to deduct the Class A customer kWhs from the total kWhs used in the computation of the proration between RPP and Non-RPP customers. In addition, Account 1589 was adjusted to include billing corrections from the Independent Electricity System Operator (IESO) made in fiscal year 2017 related to 2015 and 2016 transactions. Energy+ also revised its unbilled revenue computation with respect to Account 1589 to exclude Class A and Wholesale Market Participant kWhs, resulting in an additional adjustment to Account 1589.

### **Cambridge and North Dumfries Hydro Service Area**

The 2016 actual year-end total balance for Cambridge and North Dumfries Hydro Group 1 accounts, including interest projected to April 30, 2018, is a credit of \$5,629,833. This amount represents a total credit claim of \$0.0040 per kWh, which exceeds the disposition threshold. Energy+ proposes the disposition of this credit amount over a one-year period.

Included in the balance of the Group 1 accounts is the GA account debit balance of \$2,455,154. A customer's costs for the commodity portion of its electricity service

reflects the sum of two charges: the price of electricity established by the operation of the IESO administered wholesale market, and the GA.<sup>14</sup>

The GA is paid by consumers in several different ways:

- For RPP customers, the GA is incorporated into the standard commodity rates, therefore there is no variance account for the GA.
- Customers who participate in the Ontario Industrial Conservation Initiative program are referred to as Class A customers. These customers are assessed GA costs through a peak demand factor that is based on the percentage their demand contributes to the top five Ontario system peaks. This factor determines a Class A customer's allocation for a year-long billing period that starts in July every year. As distributors settle with Class A customers based on the actual GA costs there is no resulting variance.
- Class B non-RPP customers pay the GA charge based on the amount of electricity they consume in a month (kWh). Class B non-RPP customers are billed GA based on the IESO published GA price. For Class B non-RPP customers, distributors track any difference between the billed amounts and actual costs in the GA Variance Account for disposal, once audited.

Under the general principle of cost causality, customer groups that cause variances should be responsible for paying (or receiving credits) for their disposal. The movement from one class to another should not prevent identifiable customers from paying down/receiving a debit/credit balance.

Energy+ proposes the recovery of its GA variance account debit balance of \$2,455,154 as at December 31, 2016, including interest to April 30, 2018, in accordance with the following table.

The balance of the Group 1 accounts includes a debit of \$549,083 for the recovery of Capacity Based Recovery (CBR) charges for Class B customers related to the IESO's wholesale energy market Demand Response 3 program. Distributors paid CBR charges to the IESO in 2016 and recorded these to a dedicated sub-account. The disposition of this sub-account is impacted by whether or not a distributor had any customers who were part of Class A during the period from January 2015 to December 2016.

Cambridge and North Dumfries Hydro had Class A customers during the period from January 2015 to December 2016, so it applied to have the balance of this account disposed through a separate kWh rate rider for Class B customers in order to ensure proper allocation between Class A and Class B customers.

As some customers were reclassified between Class A and Class B during the period from January 2015 to December 2016, Energy+ requested recovery of a portion of CBR Class B costs by way of 12 equal installments.<sup>17</sup>

The remaining Group 1 accounts being sought for disposition, through the general Deferral and Variance Account rate rider, include the following flow through variance accounts: Low Voltage Charges, Smart Meter Entity Charges, Wholesale Market Service Charges, Retail Transmission Service Charges, Commodity Power Charges, and Account 1595 residual balances. These Group 1 accounts have a total credit balance of \$8,634,069, which results in a refund to customers.

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.<sup>18</sup> Energy+ further notes that its proposal for a one-year disposition period is in accordance with the OEB's policy.<sup>19</sup> OEB staff noted that the amounts should be disposed on a final basis.

### **Brant County Power**

The 2016 actual year-end total balance for Brant County Power Group 1 accounts, including interest projected to April 30, 2018, is a debit of \$636,045. This amount represents a total debit claim of \$0.0022 per kWh, which exceeds the disposition threshold. Energy+ proposes the disposition of this debit amount over a one-year period.

Included in the balance of the Group 1 accounts is the GA account debit balance of \$2,481,276. A customer's costs for the commodity portion of its electricity service reflects the sum of two charges: the price of electricity established by the operation of the IESO administered wholesale market, and the GA.<sup>20</sup>

Energy+ proposes the recovery of its GA variance account debit balance of \$2,481,276 as at December 31, 2016, including interest to April 30, 2018, in accordance with the following table.

The balance of the Group 1 accounts includes a debit for \$113,110 for the the recovery of Capacity Based Recovery (CBR) charges for Class B customers related to the IESO's wholesale energy market Demand Response 3 program. Distributors paid CBR charges to the IESO in 2016 and recorded these to a dedicated sub-account. The

disposition of this sub-account is impacted by whether or not a distributor had any customers who were part of Class A during the period from.

Brant County Power had no Class A customers during the period from January 2015 to December 2016 so it applied to have the balance of this account disposed along with Account 1580 - Wholesale Market Service Charge through the general Deferral and Variance Account rate rider.

The remaining Group 1 accounts being sought for disposition, through the general Deferral and Variance Account rate rider, include the following flow through variance accounts: Low Voltage Charges, Smart Meter Entity Charges, Wholesale Market Service Charges, Retail Transmission Service Charges, Commodity Power Charges, and Account 1595 residual balances. These Group 1 accounts have a total credit balance of \$1,845,231, which results in a refund to customers.

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.<sup>21</sup> Energy+ further notes that its proposal for a one-year disposition period is in accordance with the OEB's policy.<sup>22</sup> OEB staff noted that the amounts should be disposed on a final basis.

## Findings

The OEB reviewed the evidence provided by Energy+ and is satisfied with the adjustments made following the conclusion of the audit. The OEB is satisfied with the results of the special purpose audit provided by Energy+ and performed by KPMG LLP.

## Cambridge and North Dumfries Hydro

The OEB approves the disposition of a credit balance of \$5,629,833 as of December 31, 2016, including interest projected to April 30, 2018 for Group 1 accounts.

The following table identifies the principal and interest amounts which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*.<sup>23</sup> The date of the transfer must be the same as the effective date for the associated rates, which is, generally, the start of the rate year. Energy+ shall ensure these adjustments are included in the reporting period ending June 30, 2018 (Quarter 2).

The OEB approves these balances to be disposed through rate riders and charges as calculated in the Rate Generator Model. The rate riders, charges will be in effect over a one-year period from May 1, 2018 to April 30, 2019.<sup>24</sup>

### **Brant County Power**

The OEB approves the disposition of a debit balance of \$636,045 as of December 31, 2016, including interest projected to April 30, 2018 for Group 1 accounts.

The following table identifies the principal and interest amounts which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*.<sup>25</sup> The date of the transfer must be the same as the effective date for the associated rates, which is, generally, the start of the rate year. Energy+ shall ensure these adjustments are included in the reporting period ending June 30, 2018 (Quarter 2).

The OEB approves these balances to be disposed through rate riders as calculated in the Rate Generator Model. The rate riders will be in effect over a one-year period from May 1, 2018 to April 30, 2019.<sup>26</sup>

## 7 RESIDENTIAL RATE DESIGN

All residential distribution rates currently include a fixed monthly charge and a variable usage charge. The OEB's residential rate design policy stipulates that distributors will transition residential customers to a fully fixed monthly distribution service charge over a four-year period, beginning in 2016.<sup>27</sup> The OEB requires that distributors filing IRM applications affecting 2018 rates continue with this transition by once again adjusting their distribution rates to increase the fixed monthly service charge and decrease the variable charge consistent with the policy.

The OEB expects an applicant to apply two tests to evaluate whether mitigation of bill impacts for customers is required during the transition period. Mitigation usually takes the form of a lengthening of the transition period. The first test is to calculate the change in the monthly fixed charge, and to consider mitigation if it exceeds \$4. The second is to calculate the total bill impact of the proposals in the application for low volume residential customers (defined as those residential RPP customers whose consumption

is at the 10<sup>th</sup> percentile for the class). Mitigation may be required if the bill impact related to the application exceeds 10% for these customers.

In the Cambridge and North Dumfries Hydro service area the implementation of the transition results in an increase to the fixed monthly charge prior to the price cap adjustment of \$3.19. The bill impacts arising from the proposals in this application, including the fixed rate change, are below 10% for low volume residential customers.

In the Brant County Power service area, the starting ratios of fixed/variable charges are such that the annual changes required to transition to fully fixed rates over four years results in an increase above the identified \$4 threshold of \$4.35. The bill impacts arising from the proposals in this application, including the fixed rate change, are below 10% for low volume residential customers. Energy+ proposed that no mitigation measures are necessary.

In Energy+'s 2016 IRM decision,<sup>28</sup> the OEB found that the proposed four-year transition period is reasonable as the monthly increase of \$4.37 and the bill impact for low volume customers of 10.28% only marginally exceeded the \$4.00 and 10.00% threshold indicated in the OEB's policy. The OEB approved this exception to the policy in order to align the transition period to fixed rates for the two service areas.

## Findings

The OEB finds that the proposed 2018 increases to the monthly fixed charges are calculated in accordance with the OEB's residential rate design policy. The results of the monthly fixed charge, and total bill impact for low consumption residential consumers in the Cambridge and North Dumfries Hydro service area show that no mitigation is required. In the Brant County Power service area, while the increase in the monthly fixed charge is greater than \$4.00, the total bill impact is below 10%, therefore for the same reasons as articulated in Energy+'s 2016 IRM decision, the OEB accepts this exception to the policy. The OEB approves the increases as proposed by the applicant and calculated in the final Energy+ Rate Generator Models for Cambridge and North Dumfries Hydro and Brant County Power service areas.

## 8 OTHER MATTERS

In addition to the matters discussed above, Energy+ sought approval for the following rates and charges:<sup>29</sup>

- Continuance of the micro-FIT monthly Charge
- Continuance of the Smart Meter Entity Charge
- Continuance of the Specific Services charges and Loss Factors as approved in Cambridge and North Dumfries Hydro's last cost of service rebasing application for 2014.<sup>30</sup>
- Continuance of the Specific Service charges and Loss Factors as approved in Brant County Power's last cost of service rebasing application for 2011.<sup>31</sup>
- Continuance of Rate Riders and Adders for which the sunset date has not yet been reached for both of Energy+'s service areas.

These rate and charges were approved by the OEB in previous proceedings. No further approval is required in this Decision to include these on Energy+'s Tariff of Rates and Charges.

## 9 IMPLEMENTATION AND ORDER

This Decision is accompanied by a Rate Generator Model and a Tariff of Rates and Charges (Schedule A).

Model entries were reviewed in order to ensure that they are in accordance with last cost of service decisions of Cambridge and North Dumfries Hydro and Brant County Power, the 2017 OEB-approved Tariff of Rates and Charges, as well as to ensure that the cost, revenue and consumption results from 2016, are as reported by Energy+ to the OEB.

The Rate Generator Models were adjusted, where applicable, to correct any discrepancies. The Rate Generator Models incorporate the rates set out in the following table.

Each of these rates is a component of the “Regulatory Charge” on a customer’s bill, established annually by the OEB through a separate, generic order. The RRRP, WMS and CBR rates were set by the OEB on December 20, 2017.<sup>32</sup>

The Smart Metering Entity Charge is a component of the “Distribution Charge” on a customer’s bill, established by the OEB through a separate order. The Smart Metering Entity Charge was set at \$0.57 by the OEB on March 1, 2018, effective January 1, 2018 to December 31, 2022.<sup>33</sup> The Rate Generator Model has been adjusted to incorporate this rate.

#### **THE ONTARIO ENERGY BOARD ORDERS THAT:**

1. The Tariff of Rates and Charges set out in Schedule A of this Decision and Rate Order is approved effective May 1, 2018 for electricity consumed or estimated to have been consumed on and after such date. Energy+ Inc. shall notify its customers of the rate changes no later than the first bill reflecting the new rates.
