**Summitt Energy Management Inc.

**Applications for Electricity Retailer and
Gas Marketer Licences**

**PROCEDURAL ORDER NO. 1
April 12, 2018**

Summitt Energy Management Inc. on behalf of Summitt Energy LP (Summitt) filed two applications on February 5, 2018 with the Ontario Energy Board (OEB) under sections 50 and 60 of the *Ontario Energy Board Act, 1998* for a renewal of its gas marketer licence and electricity retailer licence, respectively. The granting of these licences would enable the applicant to continue marketing natural gas and retailing electricity in Ontario.

The OEB issued a combined Notice of Applications and Written Hearing on February 26, 2018. In that Notice, the OEB set out dates for the filing of interrogatories, responses to interrogatories and written submissions. Responses to interrogatories were due on April 12, 2018.

In a letter filed with the OEB dated April 10, 2018, Summitt requested an extension to April 20, 2018 for filing responses to OEB staff's interrogatories stating that due to the volume of the requested information Summitt requires more time respond.

The OEB will grant the extension and finds it necessary to make provision for the following matters related to this proceeding.

IT IS THEREFORE ORDERED THAT:

1. Summitt Energy Management Inc. on behalf of Summitt Energy LP shall file responses to interrogatories by **April 20, 2018**.
2. Written submissions must be filed with the OEB by **May 3, 2018**.
3. If Summitt Energy Management Inc. on behalf of Summitt Energy LP wishes to respond to the submissions, its written response must be filed with the OEB by **May 18, 2018**.

All filings to the OEB must quote file numbers EB-2018-0099 and/or EB-2018-0100, be made through the OEB's web portal at www.pes.ontarioenergyboard.ca/eservice/, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the BoardSec@oeb.ca. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
