INTRODUCTION AND SUMMARY

On August 17, 2016, a motion was brought by Milton Hydro Distribution Inc. (Milton Hydro) to review and vary certain aspects of the decision of the Ontario Energy Board (OEB) dated July 28, 2016 (the Decision) concerning Milton Hydro's electricity distribution rates for 2016.¹

Milton Hydro asserted that the OEB panel that heard the case (the Hearing Panel) erred in making its findings related to:

- The fair market value of the property located at Fifth Line and Main Street in Milton (the Property), which was sold by Milton Hydro to an affiliate in December 2015;
- The allocation to ratepayers of the capital gain on the portion of the Property not included in rate base; and
- The mechanism by which the gain allocable to ratepayers is to be paid to them.

On February 22, 2018, the OEB issued its decision on this motion (the Motion Decision). By a two to one majority, the Review Panel granted the variance relief requested by Milton Hydro. The dissenting Member would have varied only the mechanism for crediting the capital gain to ratepayers.

In order to implement the Motion Decision, the Review Panel ordered Milton Hydro to prepare a draft rate order as follows:

- For the 2016 Cost of Service year, Milton Hydro is directed to calculate its revised revenue requirement by increasing its rate base by \$506,000 and then offsetting this revenue requirement amount by \$17,595. The difference between the 2016 approved revenue requirement and the revised revenue requirement will determine the lost revenue total for 2016.
- 2) For 2017, a year where Milton Hydro's rates were adjusted using the IRM [Incentive Rate Making] formula, Milton Hydro was directed to create a revised 2016 rate schedule, and use this schedule to produce a revised 2017 rate schedule by applying the 2017 IRM formula and any other aspects of its 2017

IRM Decision. (The revised 2017 rate schedule will be used to determine the 2018 IRM rate schedule.)

- 3) Milton Hydro is then directed to calculate 2017 lost revenue by applying the revised 2017 rate schedule to 2017 actual and forecast loads to April 30, 2018, compare these revenues to the actual/forecast revenues using the actual approved 2017 rate schedule. This lost revenue shall also be offset by the \$17,595 annual capital gain credit.
- 4) Milton Hydro shall then add the 2016 and 2017 lost revenue totals and subtract the remaining capital gain amount, \$52,785, to arrive at the net lost revenue to be collected from ratepayers through a rate rider in the 2018 rate year (if a material amount).²

Milton Hydro filed its draft rate order on March 9, 2018. In accordance with the methodology set out in the Motion Decision, Milton Hydro calculated that there was a balance of \$7,876 to be returned to ratepayers. Milton Hydro explained that although the amount was not material, it would provide a one year credit of \$0.21 (or \$0.02 each month – rounded up from \$0.017) per customer, by way of a rate rider.

Intervenors and OEB staff subsequently filed their comments on the draft rate order. Energy Probe submitted that it believed that the draft rate order reflects the Decision and the School Energy Coalition indicated it had no comments on the draft rate order.

OEB staff submitted that Milton Hydro had correctly calculated the forgone revenue for 2016 and 2017, taking into account the correction of the gain on the sale of the Property and the 50/50 sharing of that gain. In addition, OEB staff specified that the rate rider to return the forgone revenue credit had been calculated correctly in order to be incorporated in the 2018 tariff.

Findings

The OEB finds that Milton Hydro's draft rate order accurately reflects the Motion Decision. The OEB therefore approves Milton Hydro's proposed credit rate rider of \$0.02 per month per customer for the May 1, 2018 to April 30, 2019 rate year.

The OEB also finds that Milton Hydro's revised tariffs of rates and charges for the 2016 and 2017 rate years accurately reflect the Motion Decision. The revised 2016 and 2017

tariff sheets are 'notional' and for calculation purposes only – the 2017 tariff will be the starting point for the OEB's 2018 IRM formula to establish the 2018 distribution rates for Milton Hydro effective May 1, 2018.³ Milton Hydro will continue to charge the approved rates from the 2017 IRM proceeding⁴, pending the outcome of the 2018 IRM proceeding.

Cost Awards

The OEB has made provision for cost awards below.

THE ONTARIO ENERGY BOARD ORDERS THAT:

- 1. Milton Hydro's proposed credit rate rider of \$0.02 per month per customer for the 2018 rate year (May 1, 2018 to April 30, 2019) is approved.
- 2. Milton Hydro's revised tariffs of rates and charges for the 2016 and 2017 rate years (attached as Schedules A and B) are approved for the purpose of calculating Milton Hydro's rates for the 2018 rate year.
- 3. Cost eligible intervenors in this proceeding shall submit their cost claims no later than 7 days from the date of issuance of this Decision and Order.
- 4. Milton Hydro shall file with the OEB and forward to all parties any objections to the claimed costs within 14 days from the date of issuance of this Decision and Order.
- 5. Cost eligible intervenors shall file with the OEB and forward to Milton Hydro any responses to any objections for cost claims within 21 days from the date of issuance of this Decision and Order.
- 6. Milton Hydro shall pay the OEB's costs of and incidental to this proceeding upon receipt of the OEB's invoice.

RESIDENTIAL SERVICE CLASSIFICATION

This classification refers to the supply of electrical energy to detached, semi-detached and townhouse residential buildings as defined in local zoning bylaws. A residential service is a single-family unit used for domestic or household purposes, including seasonal occupancy. At Milton Hydro's discretion, residential rates may be applied to apartment buildings with 6 or less units by simple application of the residential rate by blocking the residential rate by the number of units. Further servicing details are available in the distributor's Conditions of Service.

Where the residential dwelling comprises the entire electrical load of a farm, it is defined as a residential service. Where the residential dwelling does not comprise the entire electrical load of the farm:

- The service will be defined as a General Service if the occupant derives his/her principal livelihood from the working of the farm:
- The service will be defined as a Residential Service if the occupant does not derive his/her principal livelihood from the working of the farm;
- Where the residential farm dwelling is supplied by one separately metered service and the electrical loads in other buildings are supplied by a different separately metered service, then the former is defined as a Residential Service and the latter is defined as a General Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Board, and amendments thereto as approved by the Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Board, and amendments thereto as approved by the Board, or as specified herein.

Unless specifically noted, this schedule does not contain any charges for the electricity commodity, be it under the Regulated Price Plan, a contract with a retailer or the wholesale market price, as applicable.
