Re: Retailer Licence Amendment to ER-2015-0305

Dear Ms. Walli,

London Health Sciences Centre (LHSC) is seeking the following amendment to its Electricity Retailer Licence:

- To sell electricity to a small business <150,000 kWh/year.

LHSC is transferring ownership of a portion of its property to Thames Talbot Land Trust and Reforest London. These non-profit organizations are currently occupying small buildings on this LHSC owned property and being supplied electricity from the LHSC, Victoria Hospital Power Plant. Ownership of the property is set to close at the end of May, 2018. The small businesses would like to continue to receive their electricity from LHSC as there is no infrastructure currently connecting them to a local utility company and this would come at great cost to them.

LHSC's current Electricity Retailer Licence is for large volume customers only and we would like to have this amended to be able to continue to provide electricity to Reforest London at fair market value, once the sale of the property is complete.

The average annual electricity consumption for these buildings is currently 35,000 kWh.

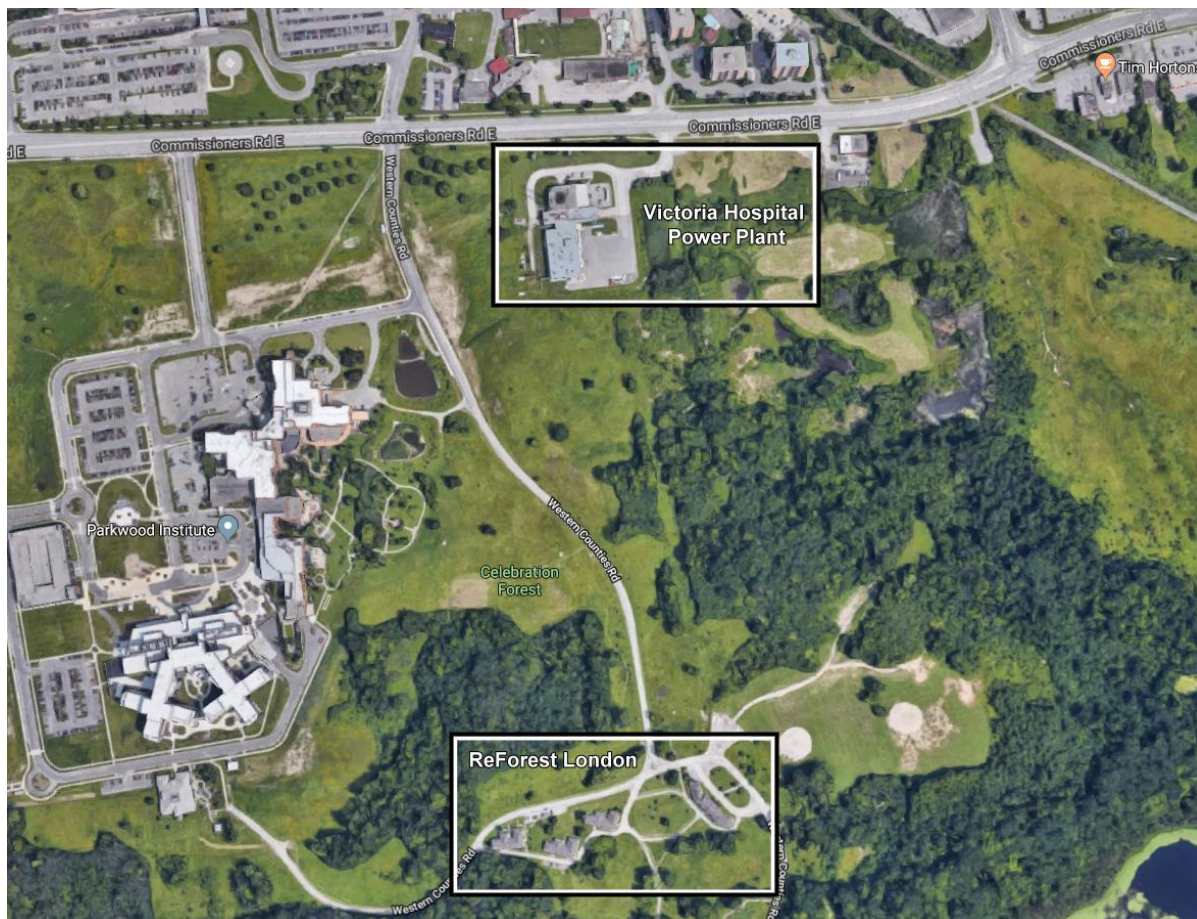
